



Product usage method





Explanation of buttons

- Power On/Off : Push the power button to the arrow direction.
- Volume control: Press +, button. The Amp THD (Total Harmonic Distortion) is 10%. We suggest you to use it by lowering 1 or 2 stages at the maximum volume.
- 3 Mute: Press mute icon x.
- 4 | Bluetooth connection methods



It operates into pairing mode when you press Bluetooth button.

Connect with Purex at the Bluetooth Device you will connect.

Pairing PN code is 0000.

You can now appreciate music freely with PUREX
