
INSTRUCTION MANUAL

BATTERY & ON/OFF SWITCH DIAGRAM AND BATTERY INSTALLATION



VEHICLE

LOOSEN THE SCREW AND OPEN THE BATTERY COMPARTMENT AT THE BOTTOM OF THE CHASSIS

- INSERT 4 x "AA" (R6) BATTERIES INTO THE BATTERY COMPARTMENT. ENSURE THE POLARITIES OF THE BATTERIES (+ AND -) MATCH THE MARKINGS ON THE BATTERY COMPARTMENT.
- CLOSE AND TIGHTEN THE BATTERY COVER.

* IMPORTANT!

SWITCH TO "OFF" POSITION AFTER USE TO AVOID DRAINAGE OF BATTERIES.

TRANSMITTER

- SLIDE THE BATTERY COMPARTMENT COVER OFF AND INSTALL 2 x "AA" (R6) BATTERIES.
- . ENSURE THE POLARITY SIGNS OF BATTERY MATCH THOSE ON BATTERY COMPARTMENT.
- REPLACE COVER.

NO. 7020 (BATTERIES NOT INCLUDED)

BATTERIES REOUIRED:

- 8 x "AA" BATTERIES FOR CARS
- 4 x "AA" BATTERIES FOR TRANSMITTERS

HOW TO OPERATE:

- 1. TURN ON/OFF SWITCH AT BOTTOM OF VEHICLE TO "ON" POSITION.
- 2. FORWARD. PUSH LEFT JOYSTICK FORWARD
- 3 REVERSE, PULL LEFT JOYSTICK BACKWARD
- 4. STEERING. MOVE RIGHT JOYSTICK IN EITHER DIRECTION TO TURN LEFT OR RIGHT.
- 5. JOYSTICKS AUTOMATICALLY RETURN TO NEUTRAL WHEN RELEASED.

NOTE: TRANSMITTER TURNS ON AUTOMATICALLY





WHEEL ALIGNMENT




ADJUST THE DIRECTION TRIMMER ON UNDERSIDE OF VEHICLE IF THE VEHICLE DOES NOT RUN STRAIGHT, TURN TO LEFT OR RIGHT UNTIL YOUR DESIRED

IMPORTANT NOTICE:



- Do not mix old and new batteries.

 Do not mix alkaline, standard (Carbon Zinc) or rechargeable (Nickel-Cadmium) batteries.
- Do not use RECHARGEABLE batteries.
- Batteries should be replaced by adults because of small parts Batteries are to be inserted with correct polarity.
- Non-rechargeable batteries are not to be charged.
- Only batteries of the same or equivalent type as recommended are to be used. Exhausted batteries are to be removed from the toy.
- Don't operate your car in dangerous places.
 Don't put your car and transmitter near any source of HEAT.
- 11. Don't run through water, including pools or puddles.
- 12. Avoid all possible collisions. Check the road ahead and watch for obstacles. 13. Avoid your car and transmitter antennas touching each other.
- 14. Don't operate your car in the vicinity as another radio-controlled car.
 15. Don't leave your car and transmitter outside overnight. Night dampness will cause harm.
- 16. Don't forget to remove batteries from your car and transmitter if you are not going to
- operate the car again that day. 17. If malfunction occurs, replace batteries.
- 18. Adult supervision is required when charging rechargeable batteries.
- 19. The supply terminals are not to be short-circuited.


