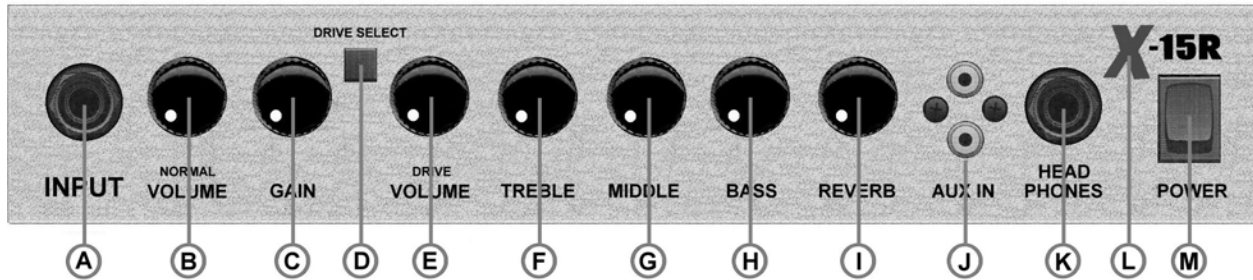




X-15R GUITAR AMPLIFIER

X-15R Front Panel Functions



- A. INPUT** – Plug your guitar in here.
- B. NORMAL VOLUME** – Adjusts the loudness of the Normal channel.
- C. GAIN**- Adjusts the amount of gain and overdrive in the DRIVE channel in conjunction with the Drive Volume control.
- D. DRIVE SELECT** – Activates the Drive channel.
- E. DRIVE VOLUME** – Adjusts the loudness of the Drive channel in conjunction with the Gain control.
- F. TREBLE** – Adjusts the high-frequency level as desired.
- G. MIDDLE** – Adjusts the middle-frequency level.
- H. BASS** – Adjusts the low-frequency level.
- I. REVERB** – Adjusts the level of the Reverb effect for both channels.
- J. AUX IN** – RCA input jacks for use with a portable CD or Tape player, drum machine, etc. These input jacks are not affected by the amplifier's volume or tone controls; adjust the signal at the source.
- K. HEADPHONES** – Output jack for standard stereo or mono headphones. Using this jack automatically disconnects the speaker. This jack may also be used as an unbalanced line output by using either a stereo or mono ¼" phone plug connection.
- L. POWER INDICATOR** – Illuminates when the unit is receiving AC power.
- M. POWER SWITCH** – This switch turns the unit ON and OFF.
