Battery Installation

IMPORTANT! Continuous link indicator on parent unit will not blink if battery power is low. Be sure to replace all three, size "AAA" batteries in each unit.

- Locate battery compartment door on the parent and child units.
- Loosen the battery compartment doors with a Phillips screwdriver. Remove the battery compartment doors.
- Insert three, size "AAA" alkaline batteries into each unit, as indicated inside the battery compartments.
- Replace the battery compartment doors, and tighten the screws. Do not over-tighten.

Battery Tips

- Do not mix old and new batteries.
- Do not mix different types of batteries: alcaline, standard (carbon-zinc) or rechargeable (nidsel codmium).
- Remove batteries during long periods of non-use. Always remove exhausted batteries from product. Battery leakage and corrosion can damage product.
- Never short circuit battery terminals.
- Non-rechargeable batteries are not to be recharged.
- Only batteries of same or equivalent type as recommended in Battery Installation Instructions are to be used.
- If removable rechargeable batteries are used, they are only to be charged under adult supervision.
- Rechargeable batteries are to be removed from product before they are charged.
- If you use a battery charger, it should be examined regularly for damage to card, plug, enclosure and other parts.
 Do not use a damaged battery charger until it has been properly repaired,
