

Programming

The FITwave receiver must be programmed to detect and lock in the FITwave transmitters as well as the other brands of transmitters listed below. The 9000Hz receiver features both "auto" and "namual" program modes. In the auto mode the 900Mtz receiver will automatically search for and "namual" program in your transmitters. The manual mode provides the ability to add or erase a popular transmitter transmitter, caused by spurious emissions or other local specific transmitter channel or unwanted frequency caused by spurious emissions or other local specific transmitter channel or unwanted frequency.



- To exit manual program mode press the button. The display will blink briefly and twill default to first transmitter channel programmed.

Attaching the Controller

- 1. Using the nylon wire tie mounting steeps (x 2);
- Feed these through the holes provided in the rear mounting support of the controller;
- Connect the RJ45 connecter into the controller, ensuring a tight and correct connection;
- Mount controller to fitness equipment location;
- Use the foam protection mat provided, place this to the bottom of the mounting bar curve and tie over this;
- Tighten as necessary to ensure a secure and strong
 attachment to the equipment.
