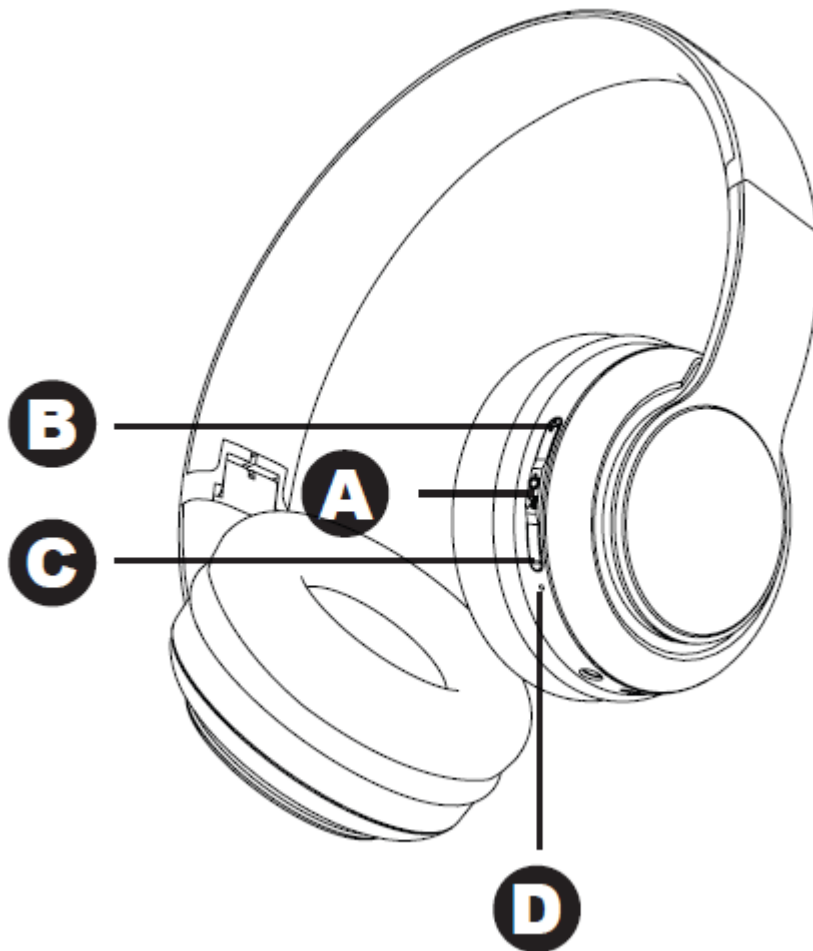


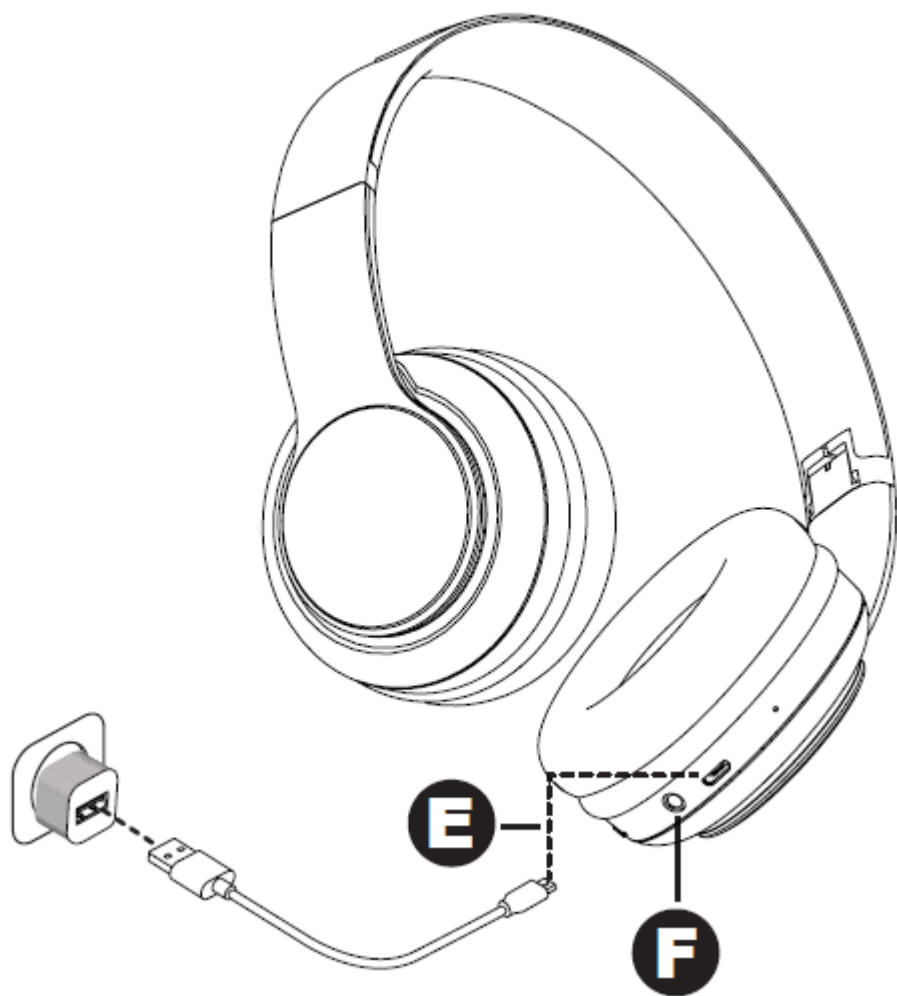

- A** Hold (3 sec): Power ON/OFF. Short press: Play/pause/answer and end call.
 - B** Short press: Skip track. Hold (1 sec): Increase volume.
 - C** Short press: Previous track. Hold (1 sec): Decrease volume.
 - D** Flashing blue: On and paired. Constant red: Powering off. Flashing blue/red: Pairing mode.
 - E** Charge headphones via input (Micro-B USB 5V/0.16A).
 - F** 3.5mm AUX line-in port.

Safety and Compliance Information:

- Do not attempt to disassemble the product or insert items into the product as this may cause short circuits resulting in electrical shock or fire.
