

# 飞智散热器B6X 磁吸版 使用说明书


## 安装磁吸片(\*带有磁吸功能的手机(苹果12/13/14系列)不需要安装)

Mount Magnetic sheet (\*Skip this step if there is magnetic function to your phone (iPhone 12/13/14 serials))

- 1.清洁手机后盖、选择粘贴位置。
- 1. clean up your device before applying.
- 2.确认透明塑料片提手,朝手机充电口方向。
- 2. Make sure that the transparent plastic sheet handle is facing the phone charging port.
- 3.将磁吸片粘贴至手机合适的位置,确保位置居中、充分贴合;建议静置1h后使用。
- 3. Attach magnetic sheet to protective film. Set it aside for 1 hour before use.



- 1.初次使用,接通电源即开启散热器的智能变频模式;确保充电器的输出功率为5V 2A或以上。
- 1. First to use: The default mode is the Smart Frequency Conversion mode. Notice: 5V 2A or higher charger output is required.
- 2.按键开关:单击可控制开启或关闭散热器。
- 2. Power Switch: Click can control the cooling fan on and off
