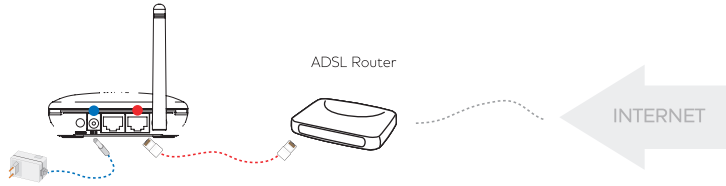

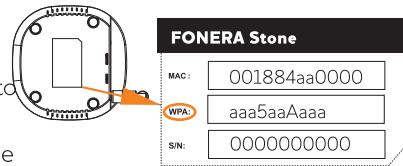
2. Connect your computer to the FONERA Stone

FCC statement

Federal Communication Commission Interference Statement
