

USING THE POWER OF DIRECT MESSAGING FOR AUTOMATING RELEASE OF INFORMATION

Release of Information:

Exchange of health information is an essential function to the provision of high-quality and cost effective healthcare. The information should be complete and timely for its intended purpose. While this sounds straightforward, it is not an easy task, especially in complex and large healthcare environments. Release of Information (ROI) in healthcare is critical to the quality of the continuity of care provided to the patient and is impactful on other important functions such as billing, research and reporting.

Even with the significant advancement of technology in healthcare, the ROI process is still completed primarily via fax, starting with the initial request through the fulfillment of the request. This causes millions of pages to be faxed on an annual basis between healthcare providers resulting in millions of dollars in inefficiencies, compromised patient care and a high risk of a breach of patient information.


With the emergence of Direct messaging, traditional fax processes are being transitioned to electronic workflows that are secure, audited and interoperable. The Release of Information process is a prime candidate for transition to Direct that could result in millions of dollars in savings for Health Information Management departments tasked with completing the process and improved patient care delivery for providers in need of the information.

Automating the ROI process for an entire community

Kno2[™] is the first and only cloud-based clinical document exchange platform that allows entire communities to connect and exchange patient information electronically using Direct messaging. Included in the Kno2 platform, is the opportunity for you to transition the Release of Information process to Direct messaging, starting with the initial request for records.

By sponsoring Kno2 out to your community for sign up, providers no longer use fax for requesting patient records. Instead, record requests are completed within Kno2 using a very simple request form(P1). The design of the form ensures that the appropriate request information and patient consents are collected the first time, thus reducing callbacks and follow-up from your HIM staff for additional information. In addition, stat requests can be prioritized to ensure timeliness of delivery

for emergent situations. Once the request is completed, the Direct message and patient consent attachment(s) are delivered to your Direct message inbox with all the necessary information. Simply reply to the request, attach the requested records and send back to the requesting provider. The message is delivered securely to their Kno2 or EMR Direct messaging inbox.
