The headset needs re-charging when the red indicator is blinking once every about 3 sec.. You can also hear a special tone of "DO-LU-DO-LU-DO" from the headset every about 40 sec.. When you talk by the headset under battery low situation, the headset red indicator is blinking 4 times every about 3 sec.. Once the low battery warning indicator starts, you have around 10 minutes of talk time left and you will then need to charge the battery in the headset.
