### Hardware Requirements

For USB input device: PC with built-in USB

For 3.5mm audio product: Device with 3.5mm audio jack

### Hardware Installation

1. For wireless models, please insert batteries properly and make sure the power switch is on.
2. Connect the device or receiver to your computer.
3. Wait till the system automatically detect the device.
4. The device is now ready to work.

Warning: A wrong battery placement may cause batteries overheat
