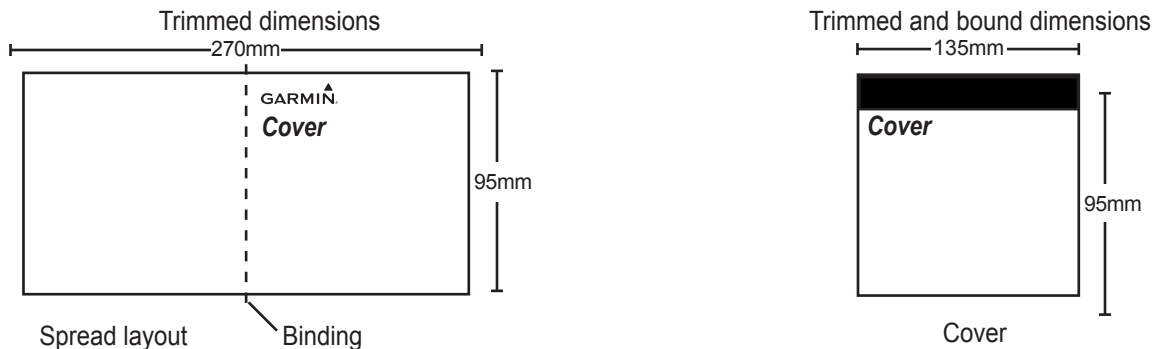

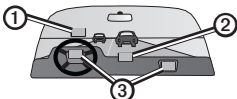
## Important Safety and Product Information

### WARNING

Failure to avoid the following potentially hazardous situations could result in an accident or collision resulting in death or serious injury.

#### Installation and Operation Warnings

- When installing the device in a vehicle, place the device securely so it does not obstruct the driver's view of the road ① or interfere with vehicle operating controls, such as the steering wheel, foot pedals, or transmission levers.
