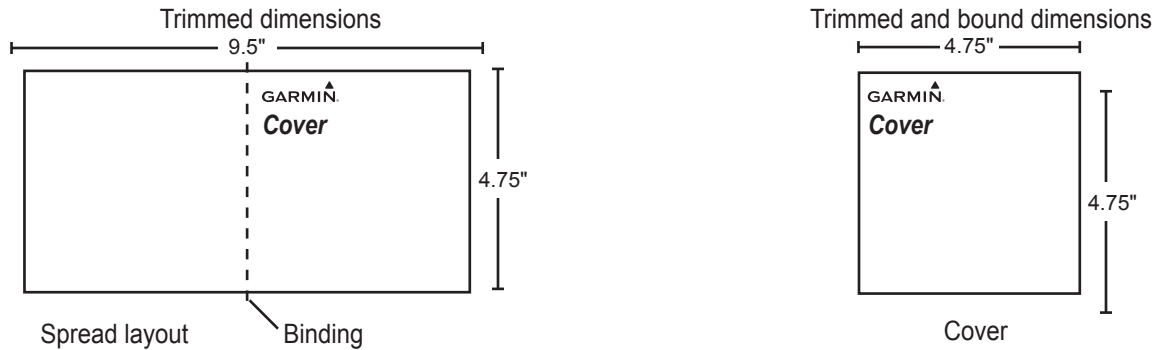

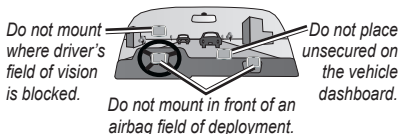
## Important Safety and Product Information

### WARNING

Failure to avoid the following potentially hazardous situations could result in an accident or collision resulting in death or serious injury.

### Installation and Operation Warnings
