

Prox-DU computer installation

Plug the USB cable into the USB port of your computer and follow the onscreen instructions when the installation wizard appears.

Prox-DU operation table

Card Indicator	Description
Off	The card interface is deactivated
Slow Blink (0,2 s / 2 s)	The card interface is ready
Blink (0,5 s / 1 s)	The card is present and inactive (powered off)
On	The card is present and active (powered on)
Flashing	The card communication is in progress

To protect the smart card from undesired operation the contactless interface is deactivated when a contact card is detected by the reader.

The contactless interface will be activated again when the smart card is removed from the slot or when a dedicated switch command is send to the reader by the application.
