### OUTLINE

#### 1. How to use RKE-4F24

- RKE-4F24 is Remote Keyless System.
- This unit controls door lock/unlock/door open (L/R)trunk/panic with wireless.

#### 2. Introduction of Transmitter (RKE-4F24)

- Transmitter has four buttons
- Transmitter use the battery
- Frequency is 433.92MHz
- Modulation item is SAW Resonator
- Transmitter use Rolling code algorithm

### GENERAL DESCRIPTION

#### PRIMARY FUNCTION

- Remote door lock/unlock/door open (L/R)/trunk/panic
- Operating distance : over 30m
- Id input (setting mode)

### Manual

#### 1) LOCK Button

If the LOCK button is pushed over 30ms, then TRANSMITTER sends the LOCK Data.

#### 2) UNLOCK Button

If the UNLOCK button is pushed over 30ms,  
then TRANSMITTER sends the UNLOCK Data.

#### 3) Door/TAILGATE Button

If the Door Open/TAILGATE button is pushed over 1000ms,  
then TRANSMITTER sends the Door Open/TAILGATE OPEN Data.

#### 4) PANIC Button

If the PANIC button is pushed over 500ms, then TRANSMITTER sends the PANIC Data.
