


Figure 1-3 Overview

Note:

- Press RESET about 10s when the camera is power on or rebooting to restore the default settings, including the user name, password, IP address, port No., etc.
- A wireless router with the WPS function is required to enable the WPS function of the camera. Refer the steps below.

Steps:

- 1. Press the WPS button on the router.
- Press the WPS button (about 2s) on the camera within 120s you enable the WPS of the router to join in the wireless network

Note:

- The WPS button works as a reset button only when you press it when the camera is powering on.
- Press the WPS button on the camera, and then press the WPS button on the router will work as well, and the expire time of WPS connection on the camera is 120s
- The link indicator blinks if the wireless connection succeeded

2 Notice

 Do not install the camera in the extreme whether condition.



 Do not install the camera towards the strong light or in the unstable lightening condition.



 Do not touch the lens with your finger.



 Do not subject the camera to vibration, shock or heavy pressure.



- High humidity may damage the camera hardware; put it in dry and well-ventilated place.
- Under no circumstances should you submerge the camera in any type of liquid.





 Electromagnetic radiation may affect the video data transmission and the image quality. Do not install the camera near radiation source.



3 Installation

Before you start:

- Make sure the device in the package is in good condition and all the assembly parts are included.
- The standard power supply is 12V DC or 24V AC, please make sure your power supply matches with your camera.
- Make sure all the related equipment is power-off during the installation
- Check the specification of the products for the installation environment.
- Make sure that the wall is strong enough to withstand four times the weight of the camera and the bracket.

For the camera that supports IR, you are required to pay attention to the following precautions to prevent IR reflection:

- Dust or grease on the dome cover will cause IR reflection.
 Please do not remove the dome cover film until the installation is finished. If there is dust or grease on the dome cover, clean the dome cover with clean soft cloth and isopropyl alcohol.
- Make sure that there is no reflective surface too close to the camera lens. The IR light from the camera may reflect back into the lens causing reflection.
- The foam ring around the lens must be seated flush against the inner surface of the bubble to isolate the lens from the IR LEDS.
 Fasten the dome cover to camera body so that the foam ring and the dome cover are attached seamlessly.

3.1 Memory Card Installation

This series of camera supports memory card installation. Follow the steps below to install the memory card.

- Insert the memory card into the card slot on the side of the camera.
- 2. (Optional) Push the inserted memory card to get it sprung out.




Figure 3-1 Install Memory Card

3.2 Stand Mounting

Steps:

1. Take the bracket out from the package.

Align the camera body to the bracket, and rotate the camera body to fix it with the bracket.

Assemble the camera as the steps above, and put the camera on the flat surface.

3.3 Ceiling Mounting

1. Drill the screw holes according to the drill template.

Disassemble the 3-axis bracket. Hold the base with one hand, and rotate the pole anticlockwise to disassemble the pole from the base.




Figure 3-5 Disassemble the Bracket

- 3. Install the fixed tray to the ceiling with the supplied screws.
- 4. Install the base to the fixed plate.




Figure 3-6 Install the Fixed Plate and Mounting Base

5. Install the camera to the bracket.

6. Adjust surveillance angel

- Loosen the knob to adjust the panning position and tilting position.
- After adjusting the angle of the camera to the desired position, fasten the knob.




Figure 3-8 Adjust the Camera

4 Setting the Network Camera over the LAN

Note:

You shall acknowledge that the use of the product with Internet access might be under network security risks. For avoidance of any network attacks and information leakage, please strengthen your own protection. 4.1 Wiring

Please connect to the camera to the network according to the following figures




Figure 4-2 Connecting via a Switch or a Router

4.2 Activating the Camera

You are required to activate the camera first by setting a strong password for it before you can use the camera.

Activation via Web Browser, Activation via SADP, and Activation via Client Software are all supported. We will take activation via SADP software and Activation via Web Browser as examples to introduce the camera activation. Please refer to the User Manual of Network Camera for Activation via Client Software.

4.2.1 Activation via Web Browser

Steps:

- 1. Power on the camera, and connect the camera to the network.
- Input the IP address into the address bar of the web browser, and click Enter to enter the activation interface.

Notes:

- The default IP address of the camera is 192.168.1.64.
- For the camera enables the DHCP by default, you need to activate the camera via SADP software and search the IP address.

Create a password and input the password into the password field.

And we recommend you reset your password regularly, especially in the high security system, resetting the password monthly or weekly can better protect your product.

- 4. Confirm the password.
- 5. Click **OK** to save the password and enter the live view interface.

4.2.2 Activation via SADP Software

SADP software is used for detecting the online device, activating the camera, and resetting the password.

Get the SADP software from the supplied disk or the official website, and install the SADP according to the prompts. Follow the steps to activate the camera, please refer to the User Manual of Network Camera for other two activation methods.

Steps:

- Run the SADP software to search the online devices.
- Check the device status from the device list, and select the inactive device

Note:

The SADP software supports activating the camera in batch. Please refer to the user manual of SADP software for details.

Create a password and input the password in the password field, and confirm the password.



STRONG PASSWORD RECOMMENDED— We highly recommend you create a strong password of your own choosing (using a minimum of 8 characters, including upper case letters, lower case letters, numbers, and special characters) in order to increase the security of your product. And we recommend you reset your password regularly, especially in the high security system, resetting the password monthly or weekly can better protect your product.

4. Click OK to save the password.

You can check whether the activation is completed on the popup window. If activation failed, please make sure that the password meets the requirement and try again.

4.3 Modifying the IP Address

Purpose:

To view and configure the camera via LAN (Local Area Network), you need to connect the network camera in the same subnet with your PC. Then, install the SADP software or client software to search and change the IP of network camera. We will take modifying the IP Address via SADP software as an example to introduce the IP address modification.

Steps:

- 1. Run the SADP software.
- 2. Select an active device.

Note:

Please refer to Chapter 4.2 to activate the camera if the camera is inactive

Change the device IP address to the same subnet with your computer by either modifying the IP address manually or checking the checkbox of Enable DHCP.

4. Input the password to activate your IP address modification.

The batch IP address modification is supported by the SADP; please refer to the User Manual of SADP for details.

5 Accessing via Web Browser

System Requirement:

Operating System: Microsoft Windows XP SP1 and above version

CPU: 2.0 GHz or higher

RAM: 1G or higher

Display: 1024×768 resolution or higher

Web Browser: Internet Explorer 8.0 and above version, Apple Safari 5.0.2 and above version, Mozilla Firefox 5.0 and above version and Google Chrome 18 and above version

Steps:

- 1. Open the web browser.
- In the browser address bar, input the IP address of the network camera, and press the Enter key to enter the login interface.

Note:

- The default IP address is 192.168.1.64.
- If the camera is not activated, please activate the camera first according to Chapter 4.2.
- 3. Input the user name and password.

The admin user should configure the device accounts and user/operator permissions properly. Delete the unnecessary accounts and user/operator permissions.

Note:

The device IP address gets locked if the admin user performs 7 failed password attempts (5 attempts for the user/operator).

4. Click Login.

Install the plug-in before viewing the live video and managing the camera. Please follow the installation prompts to install the plug-in.

Note:

You may have to close the web browser to finish the installation of the plug-in.

Reopen the web browser after the installation of the plug-in and repeat steps 2 to 4 to login.

Note:

For detailed instructions of further configuration, please refer to the user manual of network camera.

6 Operating via Hik-Connect App

6.1 Hik-Connect Setup

Steps:

- Download and install the Hik-Connect app by searching "Hik-Connect" in App Store or Google PlayTM.
- 2. Launch the app and register for a Hik-Connect user account.
- 3. Log in Hik-Connect app after registration.

6.2 Adding Device to Hik-Connect

Steps:

 Use a network cable to connect the device with a router if the device does not support Wi-Fi.

Note:

After the device connects to the network, please wait one minute before any operation on the device using Hik-Connect app.

2. In the Hik-Connect app, tap "+" on the upper-right corner and then scan the QR code of the device to add the device. You can find the QR code on the mounting base of the device or on the cover of the Quick Start Guide of the device in the device package.

Follow the prompts to set the network connection and add the device to your Hik-Connect account.

6.3 Initializing the Memory Card

Steps:

 Check the memory card status by tapping on the Storage Status in the Device Settings interface.

If the memory card status displays as Uninitialized, tap to initialize it. The status will then change to Normal. You can then start recording any event triggered video in the camera such as motion detection.
