



Figure 1-1 Appearance






Figure 1-2 Overview



Note:

Press RESET about 10s when the camera is power on or rebooting to restore the default settings, including the user name, password, IP address, port No., etc.

2 Notice

- Do not install the camera in the extreme weather condition.
- Do not touch the lens with your finger.



- Do not install the camera towards the strong light or in the unstable lightening condition.
- Do not subject the camera to vibration, shock or heavy pressure.



- High humidity may damage the camera hardware; put it in dry and well-ventilated place.

3 Installation

Before you start:

- Make sure the device in the package is in good condition and all the assembly parts are included.
- The standard power supply is 12 VDC, please make sure your power supply matches with your camera.
- Make sure all the related equipment is power-off during the installation.
- Check the specification of the products for the installation environment.
- Make sure that the wall is strong enough to withstand four times the weight of the camera and the bracket.

For the camera that supports IR, you are required to pay attention to the following precautions to prevent IR reflection:

- Make sure that there is no reflective surface too close to the camera lens. The IR light from the camera may reflect back into the lens causing reflection.
- The foam ring around the lens must be seated flush against the inner surface of the bubble to isolate the lens from the IR LEDs. Fasten the dome cover to camera body so that the foam ring and the dome cover are attached seamlessly.

3.1 Memory Card Installation

This series of camera supports memory card installation. Follow the steps below to install the memory card.

Steps:

1. Insert the memory card into the card slot on the side of the camera.
2. (Optional) Push the inserted memory card to get it sprung out.




Figure 3-1 Install Memory Card

3.2 Camera Mounting

Steps:

1. Drill the screw holes according to the drill template.




Figure 3-2 Drill Template

2. Disassemble the bracket.

3. Install the fixed tray, base and camera to the mounting place in order.




Figure 3-3 Stand Mounting




Figure 3-4 Ceiling Mounting




Figure 3-5 Wall Mounting

4. Adjust surveillance angel.

- 1). Loosen the adjusting knob 2 to adjust the panning position.
- 2). Loosen the adjusting knob 1 to adjust the tilting and rotation position.
- 3). After adjusting the angle of the camera to the desired position, fasten the two knobs.




Figure 3-6 Adjust the Camera

4 Setting the Network Camera over the LAN

Note:

You shall acknowledge that the use of the product with Internet access might be under network security risks. For avoidance of any network attacks and information leakage, please strengthen your own protection.

If the product does not work properly, contact your dealer or the nearest service center for help.

If your camera is used with HiLook NVR, refer to user manual of NVR for further operations. Otherwise, follow the steps below.

4.1 Wiring

Connect the camera to network according to the following figures.




Figure 4-1 Connect Directly




Figure 4-2 Connect via a Switch or a Router

4.2 Activate the Camera

You are required to activate the camera first by setting a strong password for it before you can use the camera.

Activation via web browser, activation via SADP, and activation via client software are all supported. We will take activation via SADP software and activation via web browser as examples to introduce the camera activation.

Note:

Refer to the User Manual of Network Camera for activation via client software.

4.2.1 Activation via Web Browser

Steps:

1. Power on the camera. Connect the camera to your computer or the switch/router which your computer connects to.
2. Input the IP address into the address bar of the web browser, and press **Enter** to enter the activation interface.

Notes:

- The default IP address of the camera is 192.168.1.64.
- The computer and the camera should belong to the same subnet.
- For the camera enables the DHCP by default, you need to use the SADP software to search the IP address.




Figure 4-3 Activation Interface (Web)

3. Create a password and input the password into the password field.



STRONG PASSWORD RECOMMENDED– We highly recommend you create a strong password of your own choosing (using a minimum of 8 characters, including upper case letters, lower case letters, numbers, and special characters) in order to increase the security of your product. And we recommend you reset your password regularly, especially in the high security system, resetting the password monthly or weekly can better protect your product.

4. Confirm the password.
5. Click **OK** to save the password and enter the live view interface.

4.2.2 Activation via SADP Software

SADP software is used for detecting the online device, activating the camera, and resetting the password.

Get the SADP software from the supplied disk or the official website, and install the SADP according to the prompts.

Follow the steps to activate the camera.

Steps:

1. Run the SADP software to search the online devices.
2. Check the device status from the device list, and select the inactive device.




Figure 4-4 SADP Interface

Note:

The SADP software supports activating the camera in batch. Refer to the user manual of SADP software for details.

3. Create and input the new password in the password field, and confirm the password.

4. Click **Activate** to start activation.

You can check whether the activation is completed on the popup window. If activation failed, make sure that the password meets the requirement and try again.

4.3 Modify the IP Address

Purpose:

To view and configure the camera via LAN (Local Area Network), you need to connect the network camera in the same subnet with your PC.

Use the SADP software or client software to search and change the IP address of the device. We take modifying the IP Address via SADP software as an example to introduce the IP address modification.

For IP address modification via client software, refer to the user manual of client software.

Steps:

1. Run the SADP software.
2. Select an active device.
3. Change the device IP address to the same subnet with your computer by either modifying the IP address manually or checking the checkbox of **Enable DHCP**.

4. Input the admin password and click **Modify** to activate your IP address modification.

The batch IP address modification is supported by the SADP. Refer to the user manual of SADP for details.

5 Access via Web Browser

System Requirement:

Operating System: Microsoft Windows XP SP1 and above version

CPU: 2.0 GHz or higher

RAM: 1G or higher

Display: 1024×768 resolution or higher

Web Browser: Internet Explorer 8.0 and above version, Apple Safari 5.0.2 and above version, Mozilla Firefox 5.0 and above version and Google Chrome 18 and above version

Steps:

1. Open the web browser.
2. In the browser address bar, input the IP address of the network camera, and press the **Enter** key to enter the login interface.

Note:

The default IP address is 192.168.1.64. You are recommended to change the IP address to the same subnet with your computer.

3. Input the user name and password.

The admin user should configure the device accounts and user/operator permissions properly. Delete the unnecessary accounts and user/operator permissions.

Note:

The device IP address gets locked if the admin user performs 7 failed password attempts (5 attempts for the user/operator).

4. Click **Login**.

5. Install the plug-in before viewing the live video and managing the camera. Follow the installation prompts to install the plug-in.

You may have to close the web browser to finish the installation of the plug-in.

6 Operate via HiLookVision App

Purpose:

HiLookVision is an application for mobile devices. With the App, you can view live image of the camera, receive alarm notification and so on.

Note:

HiLookVision service is not supported by certain camera models.

6.1 Enable HiLookVision Service on Camera

Purpose:


HiLookVision service should be enabled on your camera before using the service.

You can enable the service through SADP software or web browser.

6.1.1 Enable HiLookVision Service via SADP Software

Steps:

1. Check the checkbox of **Enable HiLookVision** on:
 - 1). "Activate the Device" page during camera activation, refer to Chapter 4.2.2.
 - 2). Or "Modify Network Parameters" page during modifying IP address, refer to Chapter 4.3.
2. Create a verification code or change the verification code.

6.1.2 Enable HiLookVision Service via Web Browser

Before you start:

You need to activate the camera before enabling the service. Refer to Chapter 4.2.

Steps:

1. Access the camera via web browser. Refer to Chapter 5.

2. Enter platform access configuration interface: **Configuration > Network > Advanced Settings > Platform Access.**

3. Select **Platform Access Mode** as **HiLookVision**.
4. Check the checkbox of **Enable**.
5. Click and read "Terms of Service" and "Privacy Policy" in pop-up window.
6. Create a verification code or change the verification code for the camera.

Note:

The verification code is required when you add the camera to HiLookVision app.

7. Save the settings.

6.2 HiLookVision Setup

Steps:

1. Download and install the HiLookVision app by searching "HiLookVision" in App Store or Google Play™.
2. Launch the app and register for a HiLookVision user account.
3. Log in HiLookVision app after registration.

6.3 Add Camera to HiLookVision

Before you start:

You need to enable the HiLookVision service on camera before adding it to your HiLookVision account. Refer to Chapter 6.1.

Steps:

1. Use a network cable to connect the camera with a router if the camera does not support Wi-Fi.

Note:

After the camera connects to the network, please wait one minute before any operation on the camera using HiLookVision app.

2. In the HiLookVision app, tap "+" on the upper-right corner and then scan the QR code of the camera to add the camera.

You can find the QR code on the camera or on the cover of the Quick Start Guide of the camera in the package.





Figure 6-4 Scan QR Code

Note:

If the QR code is missing or too blur to be recognized, you can also add the camera by tapping the  icon and inputting the camera's serial number.

3. Input the verification code of your camera.

Note:

- The required verification code is the code you create or change when you enabling HiLookVision service on camera.
- If you forget the verification code, you can check the current verification code on **Platform Access** configuration page via web browser.

4. Follow the prompts to set the network connection and add the camera to your HiLookVision account.

Note:

For detailed information, refer to the user manual of the HiLookVision app.

6.4 Initialize the Memory Card

Steps:

Check the memory card status by tapping on the Storage Status in the Device Settings interface.

If the memory card status displays as Uninitialized, tap to initialize it. The status will then change to Normal. You can then start recording any event triggered video in the camera such as motion detection.
