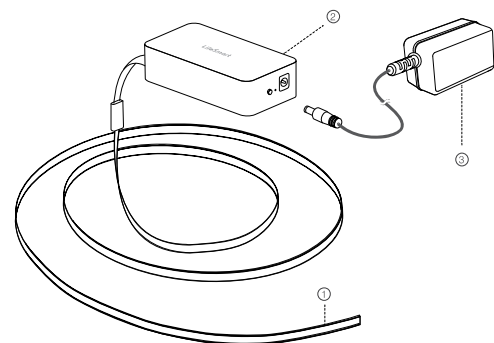

- 4 You will be prompted in the App when pairing is complete.
