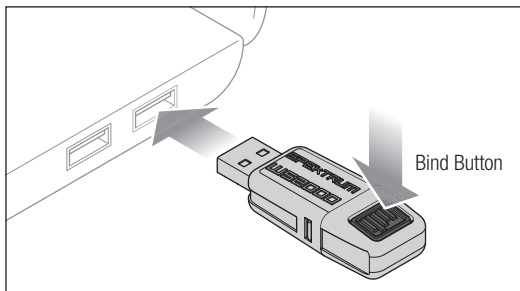

#### INSTALLATION



1. Press and hold the bind button while inserting the dongle into the USB port. The orange LED will flash repeatedly, indicating the dongle is in bind mode.
2. Follow the transmitter instructions to put the transmitter into bind mode.
3. The dongle LED will glow solid orange when the binding process is complete.
4. The transmitter is now ready to use in the simulator.

#### TROUBLESHOOTING GUIDE

Problem	Possible Cause	Solution
The SPMWS2000 will not connect, or bind, to the transmitter	The transmitter and dongle are too close together	Move the transmitter 1 to 3 meters from the dongle
	Interference	Avoid any metal or obstructions between the transmitter and dongle
	The receiver is not bound to the active model memory	Ensure you are attempting to bind to the correct model memory
