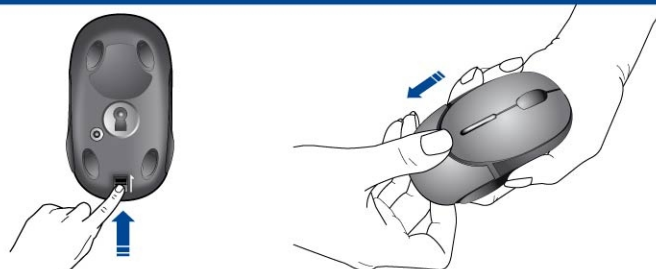

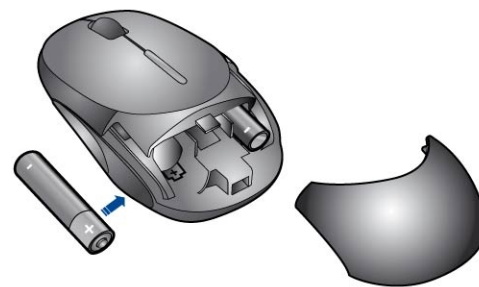


English At the bottom of the mouse, follow the direction of the arrow to push gently, at the same time, to pull out the battery cover in opposite direction, to pull out the battery cover.

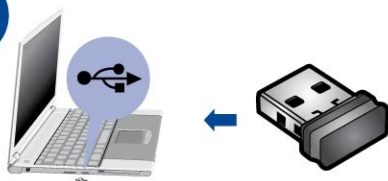

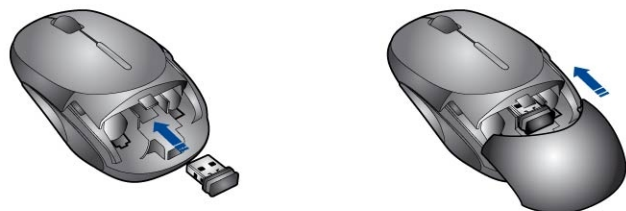
