





Vehicle will not START	Power switch is off. Make sure to turn it on. Batteries are drained. Charge batteries.		
Vehicle does not respond to controls.	Transmitter controller battery is drained. Replace the controller battery. Vehicle is out of range. Bring controller closer to the vehicle. Interference from surrounding electrical machinery. Bring to a wide open space.		
Vehicle does not drive straight.	Adjust the steering dial underneath the front axle, left or right, until the wheels point straight forward.

What does MHZ stand for and where can I find it?	MHZ stands for Megahertz, which is the frequency used to communicate between the vehicle a remote. MHZ is broken down to two frequencies, 27MHZ and 46MHZ. IT IS IMPORTANT TO NOTE, IN ORDER TO PLAY WITH 2 VEHICLES SIMULTIANEOUSLY, EACH VEHICLE MUST HAVE A DIFFERENT MHZ.
