## Troubleshooting Bluetooth®\*

Unable to Pair to Bluetooth®\* device

- Make sure device has Bluetooth®\*
   capability
- Make sure the Rocksteady XS is
   powered to the "On" position
- Reboot your Bluetooth®\* device, and power off and on your Rocksteady XS.
- Newer Bluetooth® devices will not require a pin. Should a pin be prompted, enter 0000.
