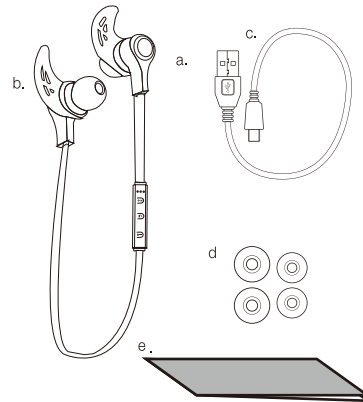

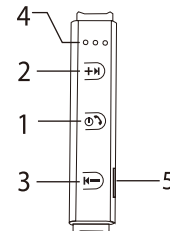

- Multifunction Button (MFB) Answer, end, reject call, Play, Pause, ON/OFF
- Next song/Volume up
- Previous song/Volume down
- Microphone
- USB charging jack

Charging the battery

This device has an internal, rechargeable battery.

- Connect the charger cable to the charging port on the controller.
- Connect the earbuds to a USB power source. The red indicator light will display during charging. If charging does not start, disconnect the charger, plug it in again, and retry. Charging the battery fully may take up to 2 hours.
- When the battery is fully charged, the red indicator light will turn off. Disconnect the charger from the USB power source and the earbuds. The fully charged battery has power for up to 3 hours of talk-time, or 3 hours music time and up to 25 hours of standby time. However, the talk, music and standby times will vary from different devices, settings, and environments.

Pairing the earbuds with a compatible phone

- Make sure your earbuds is turned off.
- Push the MFB key for about 3 seconds until the light flashes blue and red alternately.
- Activate the Bluetooth® feature on the device, and set the device to search for Bluetooth™ devices. The name of the Wireless Headset is **BB-BT-EP**. See the user guide of your device for instructions.
- If the pairing is successful, the earbuds's blue light will flash every 6 seconds.
- If pass code is requested enter (0000) Once the earbuds has paired with your device, no password will be needed to reconnect

Power ON/OFF & Reconnecting

To switch on, press and hold the MFB key until the indicator light blinks blue and red.
To switch off, press and hold the MFB key until the blue indicator light turns on and off.
Adjust volume, Press and hold the **+** to increase and the **-** to decrease volume.

Next song, Momentarily press the **+**

Previous song, Momentarily press the **-**

Pause song, press the MFB key while music is playing.

Answer a Call

To answer and end a call Press the MFB key, or use the phone keys.

(music will automatically pause during phone calls)
To reject a call Press and hold MFB key for 2 seconds, once the call is rejected successfully, release the MFB key, or use the phone keys.

Redial the last dialed out number, Press the Multifunction button twice quickly.

Battery information

Your device is powered by a rechargeable battery. The full performance of a new battery is achieved only after two to three complete charge and discharge cycles. The battery can be charged and discharged hundreds of times, but it will eventually wear out.

Do not leave a fully charged battery connected to a charger, overcharging may shorten its lifetime. If left unused, a fully charged battery will lose its charge over time.

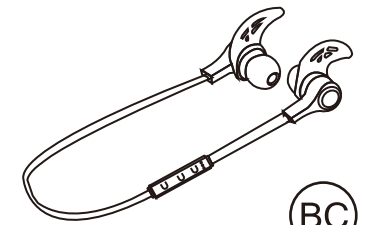
