

Hardware Installation

- 1. Install two AAA batteries in this game device.
- This game device provides two separate channels (CH.1 and CH.2). Please make sure the device and the receiver are using the same channel.






3. Connect the receiver to a USB port.

Warning.

 This game device with radio frequency gives you free action and an enjoyable experience. For optimal performance, place the receiver at least 8 inches (about 20 cm) away from other electrical devices, such as the computer, monitor, and etc.

Software Installation

Once you plug in the USB device, Windows XP/Me/2000/98 will detect it and install the driver automatically. You have to calibrate your game controller before you play any game. Click Start / Setting / Control Panel and double click on the "Game Controller" icon.
