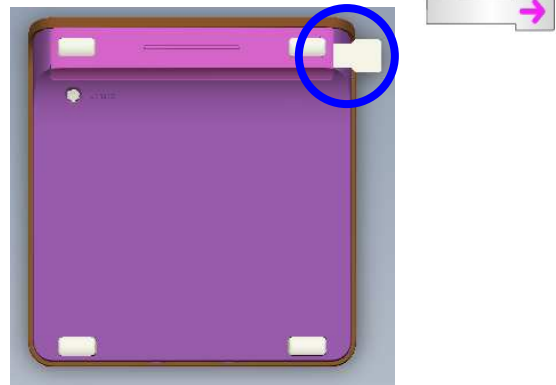

The LED for dongle will blink flash 8 times, then you can use on you PC.





