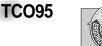

Important Precautions

This unit has been engineered and manufactured to ensure your personal safety, however improper use may result in potential eletrical shock or fire hazards. On Safety



Do you see black dots on the screen?	 This is due to a small amount of foreign or abnormally florescent material that became fastened on the mask during manufacturing. It will not affect product performance.
Do you see a partial blurring on the screen?	 This happens due to interference from surrounding magnetic fields, as created when speakers, steel structures, or high-voltage lines are placed near the monitor. Remove any such materials from the immediate vicinity and use the DEGAUSS icon on the screen adjustment menu to fix the screen.

I see an after-image on the screen.		
Do you see the after-image even when you turn off the monitor?	 A premature aging of the monitor pixels may cause the prolonged display of a single image on the screen. Be sure to use a screen saver to maximize the service life of the monitor. 	

I see waves on the screen.		
Do you see the wave directly on the screen?	 This occurs in inverse proportion to the screen focus, which can be caused by a particular frequency or video card. Brighten the screen and use the 'MOIRE' icon on the screen adjustment menu to adjust the screen.
