## Important Precautions

This unit has been engineered and manufactured to ensure your personal safety, however improper use may result in potential e shock or fire hazards. ## On Safety

- 1. Lay the monitor on a cushion or piece of soft doth with its front side facing downward.
- $\pmb{2}_{\bullet}$  Grasp the stand firmly with two hands and rotate the base while pulling out its underside.

- If the stand base is wrenched with excessive force when being folded or unfolded the monitor may be damaged. Handle with care.
- Adjust the angle of the stand base holding the monitor screen with two hands.





# Troubleshooting

Check the following before calling for service.

### No image appears

- Is the power cord of the display connected?
- Is the power indicator light on?
- Is the power on and the power indicator green?
- Is the power indicator amber?
- Do you see an "INPUT SIGNAL OUT OF RANGE" message on the screen?
- Do you see a "NO SIGNAL "message on the screen?

- Check and see if the power cord is connected properly to the power outlet.
- Press the Power button.
- · Adjust the brightness and the contrast.
- If the display is in power saving mode, try moving the mouse or pressing any key on the keyboard to bring up the screen.
- Make sure if the power is on.
- Try to turn on the PC.
- This message appears when the signal from the PC (video card) is out of horizontal or vertical frequency range of the display. See the 'Specifications' section of this manual and configure your display again.
- This message appears when the signal cable between your PC and your display is not connected. Check the signal cable and try again.

### Do you see a "CONTROLS LOCKED" message on the screen?

- Do you see "CONTROLS LOCKED" when you push MENU button?

- Check if the screen is set to interlace mode and if yes, change it to the recommend resolution.


