

Important Precautions

This unit has been engineered and manufactured to ensure your personal safety, however improper use may result in potential e shock or fire hazards. On Safety

- Adjust the angle of the stand base holding the monitor screen with two hands.




2.Slide off the lower section of the cover base with two hands as shown in the picture.
