Important Precautions

This unit has been engineered and manufactured to ensure your personal safety, however improper use may result in potential e shock or fire hazards. In order to allow the proper operation of all safeguards incorporated in this display, observe the following basic rules for its installation, use, and servicing.

On Safety

Use only the power cord supplied with the unit. In case you use another power cord, make sure that it is certified by the applicable national standards if not being provided by the supplier. Unfolding the stand base

Folding the stand base

- 1. Lay the monitor on a cushion or piece of soft cloth with its front side facing downward.
- 2. Grasp the stand firmly with two hands and rotate the base while pulling out its underside.

- If the stand base is wrenched with excessive force when being folded or unfolded the monitor may be damaged. Handle with care.
- Adjust the angle of the stand base holding the monitor screen with two hands.




