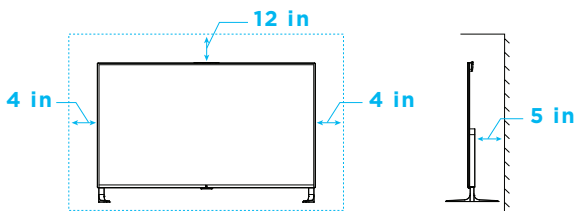
# Installation Guide

## Installation notes:

Make sure there is enough surrounding space for the Super TV as indicated below.



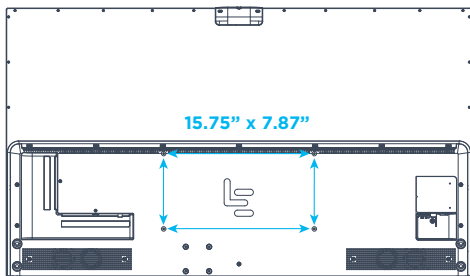
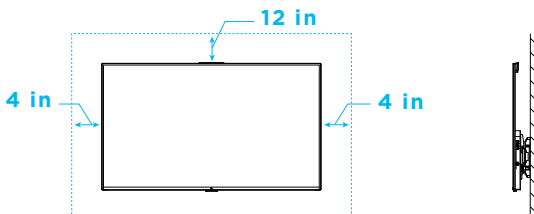

### WALL MOUNT SCREW LOCATIONS

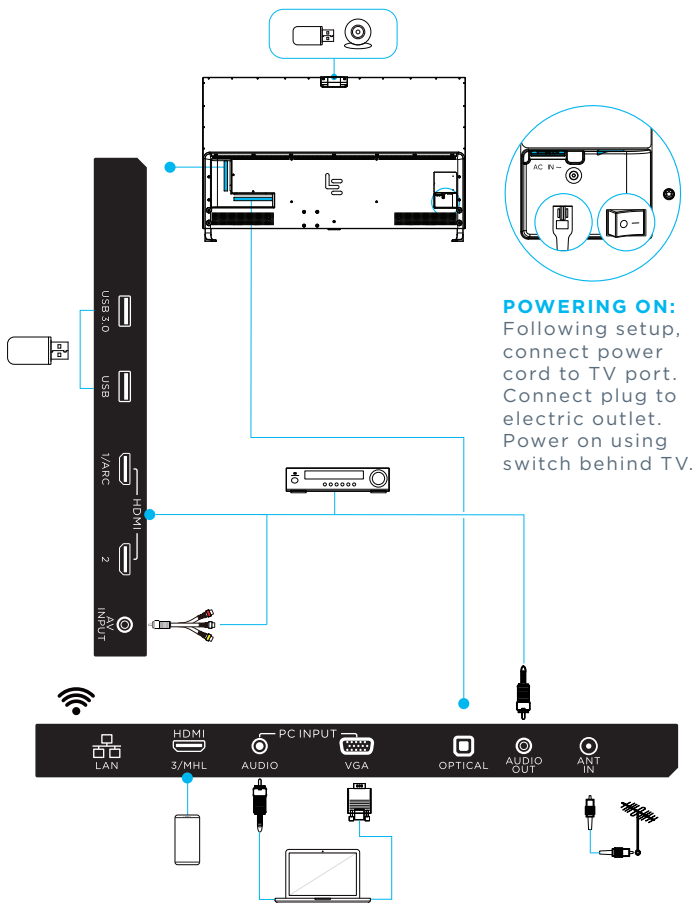

**Video Graphics Array (VGA):** Use your TV as a monitor by connecting your computer with a VGA cable\*\*.

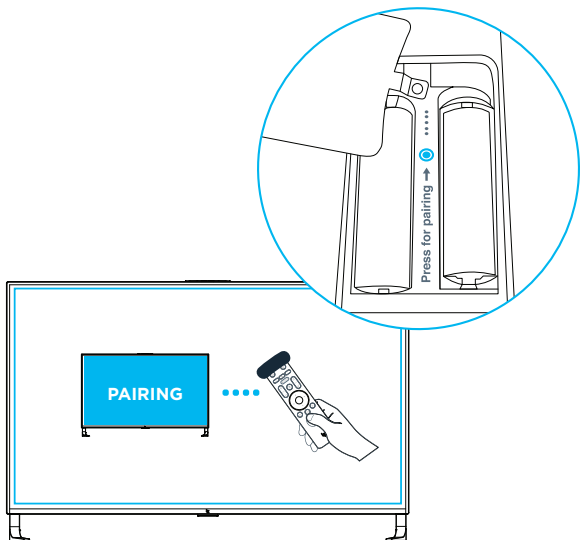

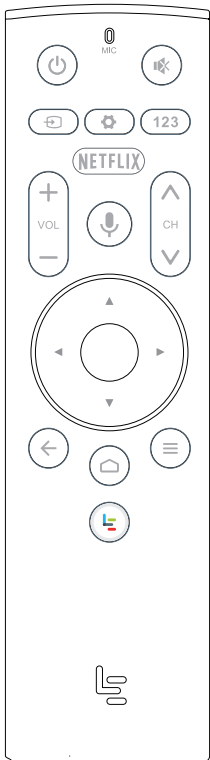
## REMOTE SET UP

# Troubleshooting

Before seeking repair service, please inspect following items and confirm whether fault symptom encountered can be solved.

Problem	Inspection item
No image or sound (TV, Video, PC)	Check 100-240V power plug is firmly inserted into power socket. Check that signal cable is connected. Check the signal source unit is properly powered on. Check the TV is not in standby mode.
No sound (TV, Video, PC)	Check the TV volume is not muted.
No video or sound, or only noise (TV)	Check the antenna is properly connected. Likely due to poor signal reception.
Poor image(TV)	Check the antenna is properly connected. Likely due to poor signal reception.
Poor image(Video)	Check correct video signal mode is selected.
Image blurring (TV)	Check the antenna connection is not loose. Likely due to poor signal reception.
Double patterning or triple patterning of video (TV)	Check the antenna is pointed to correct direction. There may be reflected signal interference from high mountain or building.
Stripe or thin hue image	Check the TV is not suffering interference from other devices. Keep away from other devices which may cause interference.

## Manufacturer’s Warranty

Le Shi Zhi Xin Electronic Technology (Tianjin) Limited (“LeEco”) represents and warrants to the original purchaser (“Purchaser”) that LeEco’s Super TV Devices and accessories (“Product”) are free from material defects, including improper or inferior workmanship, materials, and design, during the designated warranty period, and subject to the following terms and conditions, when used normally and in accordance with all operating instructions.

This warranty covers only the hardware components of the Product and does not cover any software products, whether or not included with the Product. Purchaser’s rights and obligations with respect to any software is governed by the applicable End User License Agreement.

During the warranty period, LeEco will provide repair, replacement or refund in accordance with this Policy. After the expiration of the warranty period, LeEco will provide paid repair or paid replacement in lieu of repair in accordance with this Policy.

## Seller shall be obligated to:

1. Not sell any Product listed in the sales catalog for which it cannot guarantee the implementation of the warranty policy;
2. Maintain the quality of the sold Product;
3. Implement acceptance inspection of the purchased Product, and not sell any Product that is not properly labeled;
4. Inform consumers of information related to the Product’s use, maintenance, warranty and repair service providers, and provide a valid receipt when selling the Product; and
5. Appropriately handle consumer requests and complaints and provide approximate service.

## Repairer shall be obligated to:

1. Provide repair services;
2. Protect the seller's and the manufacturer's reputation, not use any parts or components that are not compliant with the Product's specifications, make detailed records of malfunction and post-repair quality information, and ensure that after repair, the Product can work properly for at least 30 days;
3. Ensure that the repair charges and components are exclusively used for the repair, and accept supervision and inspection from the seller and the manufacturer;
4. Bear liability and losses arising from its own negligence; and
5. Respond to consumer inquiries about repair quality.

## Refund and replacement policy:

LeEco will provide replacement or refund for the Super TV in accordance with the laws of the United States:

1. 30-day refund without reasons: Purchaser is entitled to a 30-day refund for any reason by returning the Product purchased from LeMall, as received (including packaging and all accessories), within 30 days starting from the next day after receipt of the Product. LeEco will bear the corresponding shipping cost incurred for refund and replacement.

2. Refund within the warranty period: For any material malfunction of the Product confirmed through testing by LeEco or an authorized service provider within 30 days starting from the next day after receipt of the Product, Purchaser has the option of having the Product refunded at the purchase price. In case of refund, please provide the original packaging, accessories, user's manual and warranty card, and LeEco will bear the corresponding shipping cost.
3. Replacement within the warranty period: In the event of any functional fault of the Product within 30 days starting from the next day after receipt of the Product, subject to the confirmation by LeEco or an authorized service provider through testing, Purchaser has the option of having the Product repaired or replaced with a new product of the same model and specifications, and LeEco will bear the corresponding shipping cost.

## **The Product cannot be refunded or replaced in any of the following situations:**

1. Any commodities not sold by LeEco (wrong serial number);
2. The Product is damaged due to unauthorized repair, misuse, negligence, abuse, accident, modification, improper installation, or improper use;
3. Purchaser cannot provide the valid purchase receipt of the Product, or the receipt provided doesn't match the Product or is obliterated;
4. Pseudo-faults or affected performance attributable to Purchaser's setting of use, where the Product is determined to be free from any faults;
5. Other situations where replacement and refund are not supported by laws.

## **Cases where free repair is not guaranteed:**

1. Abuse, accident, misuse, improper storage, exposure to liquid, moisture, or dampness;
2. External causes such as from collision, fire, flooding, sand, dirt, windstorm, lightning, or earthquake;
3. Exposure to extreme weather conditions, Acts of God, theft, blown fuse, electrical surge, or improper use of any electrical source;
4. Computer or internet viruses, bugs, worms, Trojan Horses, cancelbots;
5. Use with non-LeEco USA products or products not recommended for use with LeEco USA Products;
6. Normal wear and tear of the equipment;

9. Consumable parts, such as batteries, unless damage has occurred due to a defect in LeEco USA materials and workmanship;

## Reminders

## Service quality warranty

1. During the warranty period, LeEco TV Technologies' authorized service provider will provide repair using the original manufacturer's parts and components according to the results of diagnosis. The Product that has parts or components replaced with new ones will be covered for the rest of the warranty period or 30 days, whichever is the longer.
2. For accessories experiencing malfunction within the warranty period, LeEco TV Technologies' authorized service provider will provide replacement with accessories of the same type and specifications, and those accessories will have a renewed warranty period.
3. Where the Product is beyond its warranty period or its problems are outside the scope of warranty, LeEco TV Technologies' authorized service provider will provide paid repair service in an efficient and professional way. The repair service will be carried out using the parts and components from the original manufacturer with a 30-day warranty period.

## Statements
