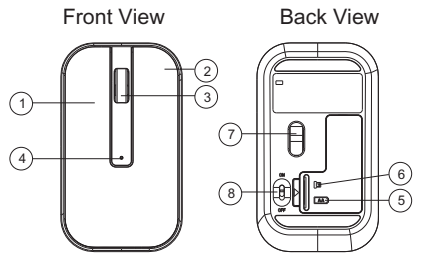


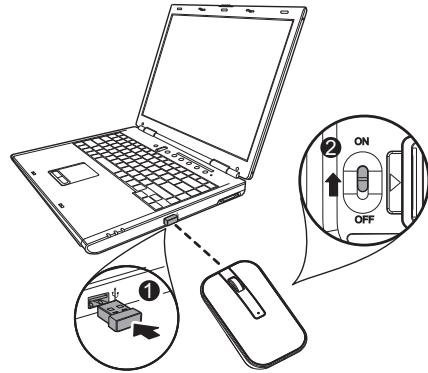

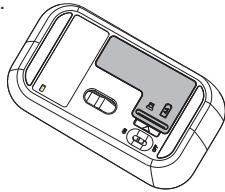
- Plug the USB dongle into an open USB port on your laptop.
- Switch the power button on the bottom of your mouse to the ON position. The laptop automatically detects the mouse.



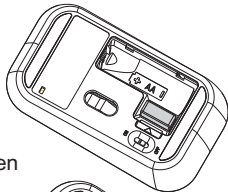
## Connecting your mouse

To connect your mouse:

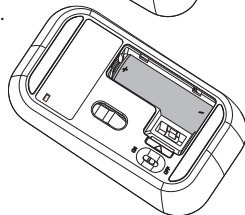
- Open the battery cover.



- Remove the USB dongle from the back of the mouse.



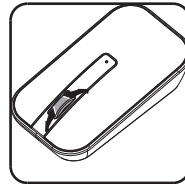
- Insert one AA battery, then replace the battery cover.

- Press and hold the scroll wheel down, then move the mouse up and down to scroll up and down the page.

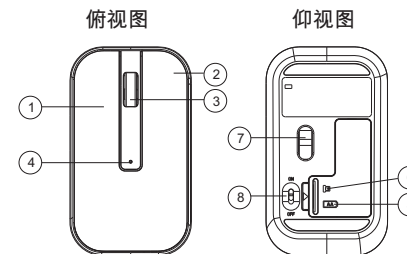


## LED Indicator

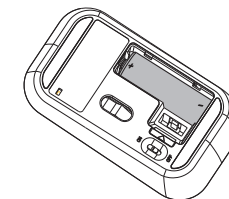
