




# 1 Charging the battery

Note: Charge your tablet fully before using it the first time.

- Connect the USB cable to your tablet.
- **2**Connect the other end of the USB cable to the USB power adapter (wall charger), then plug the adapter into a power outlet.

Caution: Use only the incuded power adapter to charge your tablet's battery. An incompatible adapter may damage your tablet.

# 4 Turning off your tablet:

- 1)Press and hold " U"(power) and "+ "(Vol+) for 1 second to turn off tablet
- 2) Tap Power Off.



## 5 Setting up your tablet
