

Warnings and Precautions

TO PREVENT FIRE OR SHOCK HAZARDS, DO NOT EXPOSE THIS UNIT TO RAIN OR MOISTURE.



This symbol, located on back or bottom of the unit, is intended to alert the user to the presence of uninsulated “dangerous voltage” within the product’s enclosure that may be of sufficient magnitude to constitute a risk of electric shock to persons.



This symbol, located on back or bottom of the unit, is intended to alert the user to the presence of important operating and maintenance (servicing) instructions in the literature accompanying the appliance.



This product utilizes a Class 1 laser to read Compact Discs. This laser Compact Disc Player is equipped with safety switches to avoid exposure when the CD door is open and the safety interlocks are defeated. Invisible laser radiation is present when the CD Player’s lid is open and the system’s interlock has failed or been defeated. It is very important that you avoid direct exposure to the laser beam at all times. Please do not attempt to defeat or bypass the safety switches.

CAUTION: TO PREVENT ELECTRIC SHOCK, MATCH WIDE BLADE OF PLUG TO WIDE SLOT, FULLY INSERT.

To reduce the risk of electric shock, do not remove cover (or back). There are no user-serviceable parts inside. Please refer any servicing to qualified service personnel.

WARNING: Changes or modifications to this unit not expressly approved by the party responsible for compliance could void the user’s authority to operate the equipment.

Important Safety Instructions

1. **Read Instructions** - All the safety and operating instruction should be read before the product is operated.

The apparatus shall not be exposed to dripping or splashing and that no objects filled with liquids, such as vases, shall be placed on apparatus.
8. **Accessories** - Do not place this product on an unstable cart, stand tripod, bracket, or table. The product may fall, causing serious injury to a child or adult, and serious damage to the product. Use only with a cart, stand, tripod, bracket, or table recommended by the manufacturer, or sold with the product. 
10. **Ventilation** - Slots and openings in the cabinet are provided for ventilation and to ensure reliable operation of the product and to protect it from overheating, and these openings must not be blocked or covered. The openings should never be blocked by placing the product on a bed, sofa, rug, or other similar surface. This product should not be placed in a built-in installation such as a bookcase or rack unless proper ventilation is provided or the manufacturer's instruction have been adhered to.
11. **Power Sources** - This product should be operated only from the type of power source indicated on the marking label. If you are not sure of the type of power supply to your home, consult your product dealer or local power company. For products intended to operate from battery power, or other sources, refer to the operating instruction.
12. **Grounding or Polarization** - This product may be equipped with a polarized alternating-current line plug (a plug having one blade wider than the other). This plug will fit into the power outlet only one way. This is a safety

feature. If you are unable to insert the plug fully into the outlet, try reversing the plug. If the plug should still fail to fit, contact your electrician to replace your obsolete outlet. Do not defeat the safety purpose of the polarizes plug.

Alternate Warnings - This product is equipped with a three-wire grounding-type plug, a plug having a third (grounding) pin. This plug will only fit into a grounding-type power outlet. This is a safety feature. If you are unable to insert the plug into the outlet, contact your electrician to replace your obsolete outlet. Do not defeat the safety purpose of the grounding-type plug.

13. **Power-Cord Protection** - Power supply cords should be routed so that they are not likely to be walked on or pinched by items placed upon or against them, paying particular attention to cords at plugs, convenience receptacles, and point where they exit from the product.
14. **Protective Attachment Plug** - The product is equipped with an attachment plug having overload protection. This is a safety feature. See Instruction Manual for replacement or resetting of protective device. If replacement of the plug is required, be sure the service technician has used a replacement plug specified by the manufacturer that has the same overload protection as the original plug.
15. **Outdoor Antenna Grounding** - If an outside antenna is connected to the receiver, be sure the antenna system is grounded so as to provide some protection against voltage surges and built-up static charges. Article 810 of the National Electrical Code, ANSI/NFPA 70, provides information with regard to proper grounding of the mast and supporting structure, grounding of the mast and supporting structure, grounding of the lead-in wire to an antenna-discharge unit, size of grounding conductors, location of antenna-discharge unit, connection to grounding electrodes, and requirements for the grounding electrode.

16. **Lightning** - For added protection for this product during a lightning storm, or when it is left unattended and unused for long periods of time, unplug it from the wall outlet and disconnect the antenna or cable system. This will prevent damage to the product due to lightning and power-line surges.
17. **Power Lines** - An outside antenna system should not be located in the vicinity of overhead power lines or other electric light or power circuits, or where it can fall into such power lines or circuits. When installing an outside antenna system, extreme care should be taken to keep from touching such power lines or circuits as contact with them might be fatal.
18. **Overloading** - Do not overload wall outlets, extension cords, or integral convenience

receptacles as this can result in a risk of fire or electric shock.

19. **Object and Liquid Entry** - Never push objects of any kind into this product through openings as they may touch dangerous voltage points or short-out parts that could result in a fire or electric shock. Never spill liquid of any kind on the product.
20. **Servicing** - Do not attempt to service this product yourself as opening or removing covers may expose you to dangerous voltage or other hazards. Refer all servicing to qualified service personnel.

22. **Replacement Parts** - When replacement parts are required, be sure the service technician has used replacement parts specified by the manufacturer or have the same characteristics as the original part. Unauthorized substitutions may result in fire, electric shock, or other hazards.

23. **Safety Check** - Upon completion of any service or repairs to this product, ask the service technician to perform safety checks to determine that the product is in proper operating condition.





Plug the detachable AC cord into a standard AC outlet (120V~60Hz)






Control Definitions

1. Pair Button ■

Press this button once to stop this disc during playing in the CD mode.

Press this button once to go into pairing mode in Bluetooth mode.

2. Program Button

Press the Program Button, in *CD mode* to program up to 20 CD tracks.

3. Play/Pause Button

Press the Play/Pause Button to play or pause a loaded CD.

4. Repeat Button

Press the Repeat Button once to repeat the current CD track.

Press the Repeat Button twice to repeat the entire album.

5. Skip/Backward Buttons ◀◀

Press the Skip/Backward Buttons to skip between CD tracks.

Press and hold the Skip/Backward Buttons to search through a single CD track.

6. Skip/Forward Buttons ▶▶

Press the Skip/Forward Buttons to skip between CD tracks.

Press and hold the Skip/Forward Buttons to search through a single CD track.

7. Battery Compartment

6 C batteries, not included.

8. AC Power Input

Use the AC Power Input to connect the unit to an AC power source.

9. Auxiliary Input

Use the Auxiliary Input to connect an external audio source (MP3 player) to the unit.

10. Volume Dial

Turn the Volume Dial to adjust the volume of the unit.

11. Tuning Dial

Turn the Tuning Dial to adjust the AM or FM radio station.

12. Function Switch (*BT, CD/AUX, FM, AM*)

Adjust the Function Switch to select Bluetooth, CD, AUX, FM and AM mode.

Bluetooth Operation

Step 1: Power on the external BT Device and enter to BT mode.

Step 2: Slide the Function Selector to BT position to turn on the Bluetooth. The Bluetooth Indicator will blink and go into the pairing mode.

Step 3: Turn on your Bluetooth device and select “Sylvania SRCD505BT”, then tapping it to connect with your Bluetooth device. After successfully connected and the Bluetooth Indicator will illuminate.

Step 4: If pairing is complete you may now play music with your external BT Device.

Step 5: When finished listening, slide the Function Selector to OFF position to shut off the unit. The Power Indicator will turn off.

Note: If any password required, enter the password ‘0000’ to confirm to pairing.

Tuning the AM or FM Radio

Step 1: Slide the **Power Switch** to ON.

Step 2: Slide the **Function Switch** to AM or FM

Step 3: Turn the **Tuning Dial** to the desired AM or FM station.

Playing a CD

Step 1: Release the CD door, and place a CD or CD-R/RW into the player.

Step 2: Slide the **Function Switch** to CD/AUX mode.

Step 3: Press the Play/Pause Button to begin playing the loaded CD.

Programming a CD

Step 1: Release the CD door, and place a CD or CD-R/RW into the player.

Step 2: Slide the **Function Switch** to CD/AUX mode.

Step 3: Press the **Program Button**.

Step 4: Press the **Skip/Backward/Forward Buttons** to select the CD track to play.

Step 5: Press the **Program Button**.

Step 6: Repeat *Steps 4-5* to program up to 20 total CD tracks.

Using the Auxiliary Input

Audio Source	Required Connector
MP3 Player	mini-phono 3.5mm Cable (not included)

Step 1: Connect a *mini-phono 3.5mm Cable* (not included) to the **Auxiliary Input** on the unit and the audio output on an MP3 player.

Step 2: Slide the **Function Switch** to CD/AUX mode.

- *Audio played through the connected MP3 player will now be heard through the unit.*
