2.1 Operation summary

2.1.1 Fob Key

① It has the functions for passive entry and passive start including the previous RKE function

2.1.2 Immobilizer & SSB(StartStopButton)

① Fob Key has the TP for emergency authentication for passive start.

② It's a button to control engine start including power transition according to each terminal status

③ To indicate terminal status,two LEDs for backlight and one for text illumination are used

④ It also has TP coil to take action for emergency.
