


## **Powering Up**

The tool can receive power via either of the following ways:

### Method 1: Via Diagnostic Cable

Connect the diagnostic cable of the tool to the vehicle's DLC (Data Link Connector) port.

\*Note: The DLC is usually located 12 inches from the center of the instrument panel (dash), under or around the driver's side for most vehicles. See diagram for possible DLC location.



#### Method 2: Via Data Cable

Connect one end of the included data cable to charging port of the tool, and the other end to the PC



This device was tested for typical body-worn operations with the back of the handset kept 0mm from the body.
