# 1. Introduction ---

Thank you for purchasing our HE8's wireless Bluetooth earphone. The HE8's use Bluetooth technology to provide a wireless connection to your mobile phone, tablets, and other devices. With the wireless connection you can enjoy music, your favorite internet radio or the latest podcast. Using the built-in microphone you can answer calls, talk on your phone or smart device using the HE8 earphones.

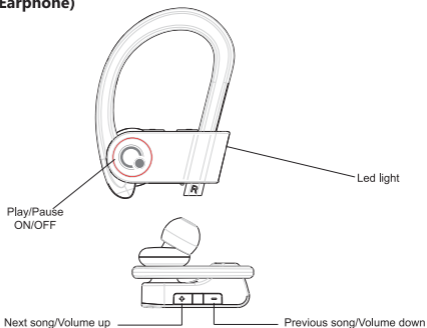
# 2. Battery Precaution ---

- The HE8 is powered by a built-in rechargeable lithium battery.
- Please charge the battery before using your HE8 for the first time. Initial charge time could take up to 5 hours.
- If the device is not used for a long period of time, the battery may lose power and needs recharged.
- Rechargeable batteries are only to be charged with adult supervision.
- Use only the supplied micro USB cable to recharge the battery.
- Improper charging may damage the battery and the device.
- Do not attempt to open the rechargeable battery pack. There are no serviceable parts inside.
- Keep the battery out of reach of children. If swallowed, consult a physician immediately.
- Do not dispose of batteries in a fire.
- Damaged batteries could be a hazard. Please dispose of them according to local regulation.
- Do not dispose them as household waste.

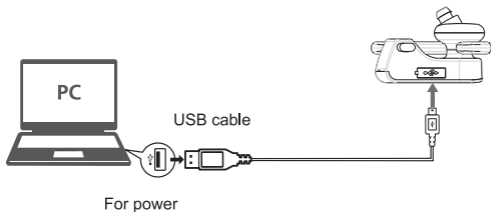

## 5. Bluetooth Connection

---

**Pairing wireless HE8 earphone to your smart device. Make certain the smart device and your HE8's are approximately 3 yards or closer to each other.**

1. Turn the HE8's "On". (note On/Off/Play/Pause button in Section 3 above). To activate pairing mode, press and hold the On/Off/Play/Pause button for a long press (a long press is more than 3 sec.) on HE8 earphone .
2. The LED will start to flash a Blue/Red color. The HE8 is searching for your smart device's signal. (note Section 3 above to locate the LED light location on your HE8 earphones).
3. Turn your smart device Bluetooth function "On".
4. Your smart device with the Bluetooth turned "On", will automatically search for the HE8 earphone Bluetooth signal.
5. The first time pairing of your smart device and the HE8 wireless earphone may require going to the Bluetooth "Settings" on your smart device. (refer to your smart device owner's manual to locate Bluetooth "Settings" function).;
  - a) When in the "Bluetooth "Settings" in your smart device, press "Scan/Searching for Devices" to locate the HE8 Bluetooth signal.
  - b) When "HE8" appears in your Bluetooth "Settings" mode, press to select.
  - c) If password/PIN is requested by smart device, enter 0000.
  - d) Press the "Enter" or "Connect" key (depends on your model of Smart Device) to pair the HE8 earphone and your smart device.
6. When the smart device and earphone are paired the LED light on the HE8 will flash "Blue" . Blue flashing light is the signal you have successfully paired your HE8 earphones and your smart device.
7. The HE8 will confirm pairing with a voice message saying "connected".

8. If pairing is unsuccessful on first try, turn " OFF" your HE8 headphone (LED light will turn "Off" completely). Complete steps 1. through 7 again.

9. With Bluetooth "On" (both devices), smart device and HE8 will automatically pair when the devices are within approximately 3 yards from each other.

## 6. Function Guidance

---

### Play music/answer calls from your phone

Button	Operation	Function
+	Long Press	Next song
+	Short Press	Volume up
-	Long Press	Previous song
-	Short Press	Volume down
○	Short Press	Pause, Answer/End a call

### Make a call

When you receive or make a call from your mobile phone, and your HE8 and your mobile phone are "On" and "paired", your call will automatically transfer to your HE8 wireless earphones.

### Answer /end a call

1. When a call is coming into your mobile phone, and the phone and HE8 are "paired", a short press on the On/Off ○ button, you can answer the call.
2. When you finish the call, short press ○ again, the call is ended .

## Listen to your favorites, stored or accessed by your mobile phone

When your mobile phone and HE8 are "paired" you can listen to the music located on your phone, your favorite podcast or your favorite internet radio using your HE8 earphones.

## 8. Battery Charging

---

The HE8 earphones has a built-in rechargeable battery. The HE8 can be charged by USB cable provided connected to your computer (note Section 4 above) or connect to the AC adaptor that normally comes with your mobile phone. When the HE8 is charging, the LED light (note location in Section 3 above) is solid Red.

After charging, your HE8 is ready to use. Your HE8 will require charging periodically.

## 9. Product care

---

Your HE8's are designed as a light, compact, durable earphone. Like all electronic devices, the HE8 must be treated carefully. Unnecessary pressure on it or striking the device against other objects can cause damage.

To avoid damage to your device, please:

- Do not drop, crush, bend or apply excessive force to the device.
- Do not expose your device to moisture, extreme or prolonged heat, cold, humidity, or other adverse conditions.
- Avoid storing it in damp, humid or wet places. It is not waterproof.
- Do not operate or store unit in places with frequent static electricity or electrical noise (e.g. speaker, TV set)
- Clean the unit with a soft cloth or damp chamois leather. Never use solvents.
- The Unit can only be opened by qualified personnel.
- This device contains magnets. Keep magnetic field sensitive products such as credit cards and video screen away from this device to avoid damage or malfunction.



## 10. FCC Compliance Statement \_\_\_\_\_

This device complies with Part 15 of the FCC Rules. Operation is subject to the following two conditions:

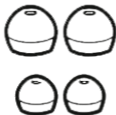

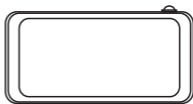
