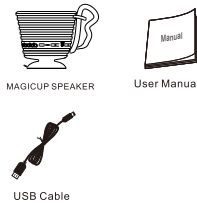

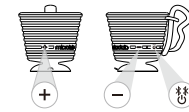

Questions	Solutions
Speaker will not turn on (battery power)	Battery may be in low level or discharged, please recharge it at least half an hour before using.
No Sound	Check if the media player is correctly connected. Check if the Bluetooth connection is correctly paired and connected.
Pairing failed	Please remove previously paired devices from your audio devices, and then "search for devices" again. Reconnect and try again.
Sound is distorted	Check if the source file is not corrupted, play a different song and test.
Reset	If the speaker makes a noise or buttons are ineffective, please long press + and - button to reset the speaker.
