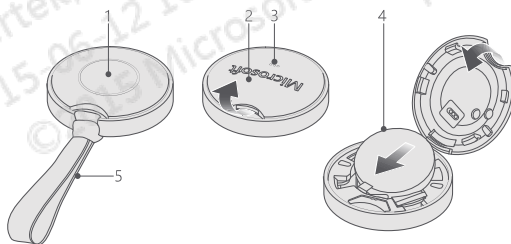

The app and a full list of compatible phones are available in Store. For compatibility with Android 4.4 or higher and IOS 6.0 or higher, check the availability of apps in the relevant store.

Get started

1. To switch your sensor on, open the back cover, insert the battery, and replace the back cover. Your sensor starts searching for compatible devices.
2. On your phone, switch Bluetooth on, open the Device hub app, and follow the instructions shown on the phone.
3. Tap **Customise** to set up your sensor.
