



How do I get started

Note: Before you begin, check if your vehicle is fitted with a heat-reflective or heated windscreen. If so, you may need to purchase an external GPS antenna for your device to receive GPS signals.

The first time you navigate with your device, it may take several minutes to establish a GPS connection. For more information on viewing your GPS status see the full User Manual on the enclosed DVD.

 Position you device in your vehicle according to the installation instructions at the front of the manual.

CAUTION: Ensure that your device does not obstruct drivers view, or interfere with the operation of the vehicle airbags and safety devices.

2. For the initial start up, press the power button for 5 seconds to turn on your device.



Note: The battery may not be fully charged when you use your device for the first time. To charge the battery, refer to the *User Manual*.
