- 2 Turn headset on (charge before use).
 - * Status Light - Flashing Blue
 - ◀ Voice prompt: "ready to pair"
Follow voice prompts.
- 3 Enter passcode.

Enter "0000" if prompted.
- 4 Complete.
 - ◀ Voice prompt: "Device 1 connected"

MUSIC

To...	
play/pause music	Press the MFB button once.
skip to next track	Press the MFB button two times.
skip to previous track	Press the MFB button three times.
change music bass/treble setting	Press and hold MFB button until you hear a voice prompt.

CALLS

To...	
answer a call	Press the MFB button.
reject a call	Press and hold a Volume button until you hear a tone.

To...	
make a voice dial call	Press and hold the MFB button until you hear a tone.
mute or unmute a call	Press and hold both Volume and Volume buttons at the same time until you hear "mute on" or "mute off".
end a call	Press the MFB button.
answer second incoming call	Press the MFB button.
reject second incoming call	Use the phone keypad to reject a second incoming call.
hear remaining music play time	Press Volume buttons while in standby.

SECOND DEVICE?

Do you use two phones? Or maybe a tablet and a phone? Pair with two devices using integrated multipoint technology.

- See "**CONNECT & GO**" on page 3 to pair second device. Headset remains in pairing mode for five minutes after turning on.
- Once paired, to connect to both devices simply turn them on.

CALLS

Follow the voice prompts for features such as voice dial, answer call, and end call.

MUSIC

Select a music source to listen to by streaming music from that phone. To switch to the other phone for music, just start streaming music from that phone.

Note: While multipoint connections work for calls, only one music streaming connection can be maintained at a time.

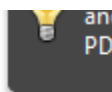
SETTINGS

- Voice answer on/off

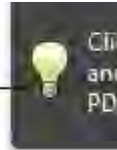

Battery Use & Safety

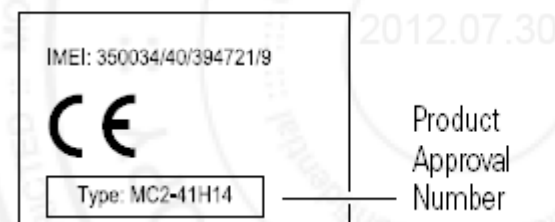

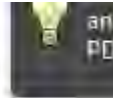

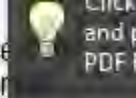
