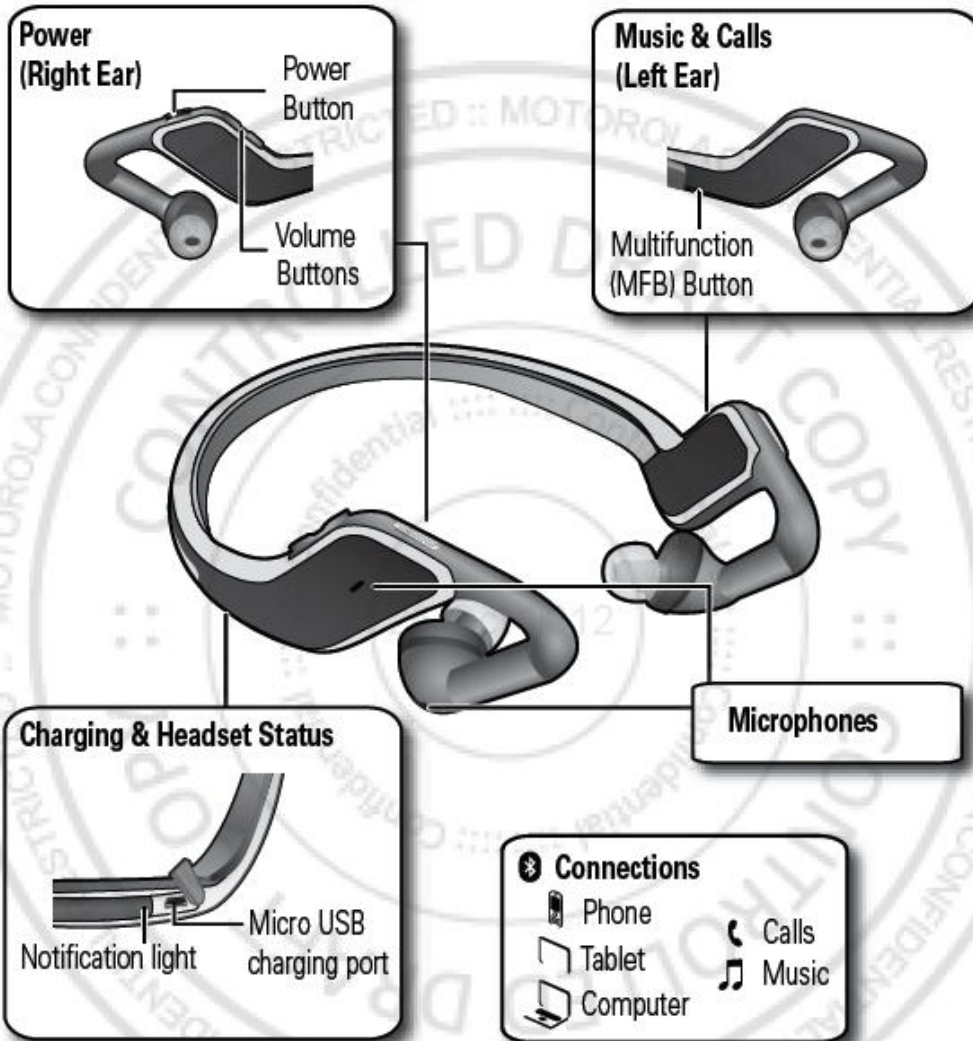


## AT A GLANCE



**Tip:** Be sure to completely close the USB charging cover to protect it from water or sweat damage.


# CHARGE & CONNECT

To charge your device, plug the micro USB cable into the charging port.

- **Red or Yellow:** Headset is charging.
- **Green:** Headset is fully charged.

Then connect your headset to a device:


**1** Turn Bluetooth on for your device.



**2** Turn fully charged headset on.

\* Status Light - Flashing Blue

**3** Enter passcode.




Enter "0000" if prompted.


# BASICS

## WEAR IT

**1** Choose ear gel.  
Choose gels that create an optimal fit.



**2** Place on ear and adjust the ear stem.



## MUSIC

To...	
play/pause music	Press the MFB button once.
skip to next track	Press the MFB button two times.
change music bass/treble setting	Press and hold MFB button until you hear a tone.

## CALLS

To...	
answer a call	Press the MFB button.

To...	
reject a call	Press and hold a Volume button until you hear a tone.
make a voice dial call	Press and hold the MFB button until you hear a tone.
mute or unmute a call	Press and hold both Volume buttons at the same time until you hear "mute on" or "mute off".
end a call	Press the MFB button.
answer second incoming call	Press the MFB button.
reject second incoming call	Use the phone keypad to reject a second incoming call.
hear remaining music play time	Press both volume buttons while in standby.

**Note:** Some features are phone/network dependent.

## **ADVANCED**

### **SECOND DEVICE**

Do you use two phones? Or a tablet and a phone? Pair with two devices using integrated multipoint technology.

- Turn off your currently paired device, then pair your second device. See "**CHARGE & CONNECT**" on page 3.
- Once paired, to connect to both devices simply turn them on.

### **MUSIC**

Select a music source to listen to by streaming music from that phone. To switch to the other phone for music, just start streaming music from that phone.

**Note:** While multipoint connections work for calls, only one music streaming connection can be maintained at a time.

### **RESET HEADSET**

Press and hold the MFB and both volume buttons to restore your headset to factory settings.

**Caution:** Reset erases all paired devices stored in your headset.

## Battery Use & Safety

### DON'Ts

- **Don't let the product come in contact with liquids.\*** Liquids can get into the product's circuits, leading to corrosion.
