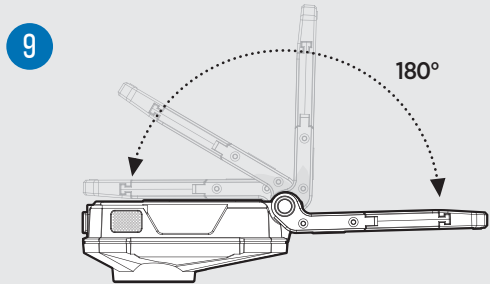
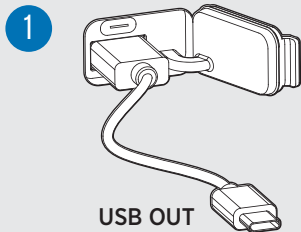
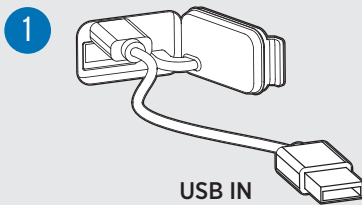
SOLUTIONS

2. Too many Bluetooth devices in the proximity that cause difficulty in connection. Please turn them off.

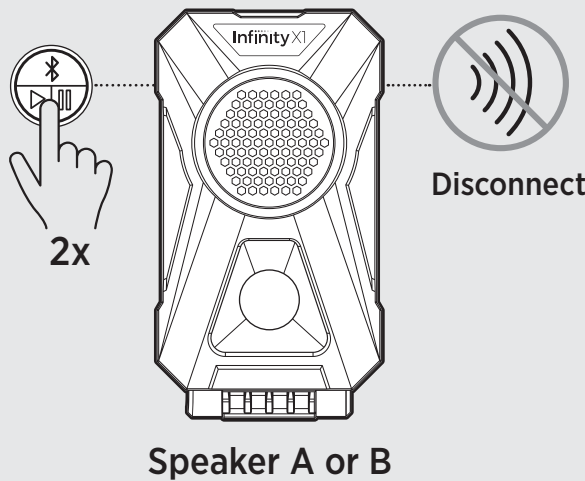
1. Check the Bluetooth device's volume and then adjust it to a proper level.
