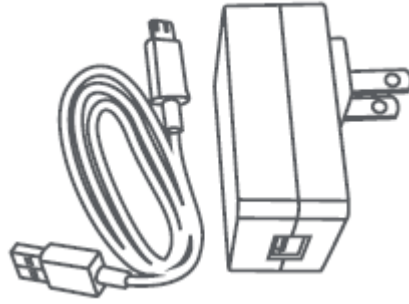

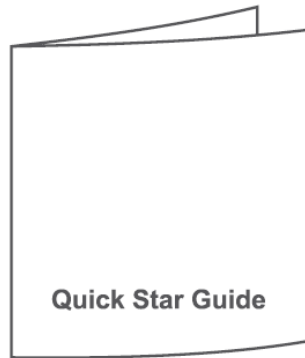

Attentions

Better put device in open areas far away from metal, avoid placing behind furniture or near microwave oven. Keep away from the environment where there are audio cable, video cable and data cable winding , or hold space as large as possible. Stay within the range of WIFI signal, as close as possible.
