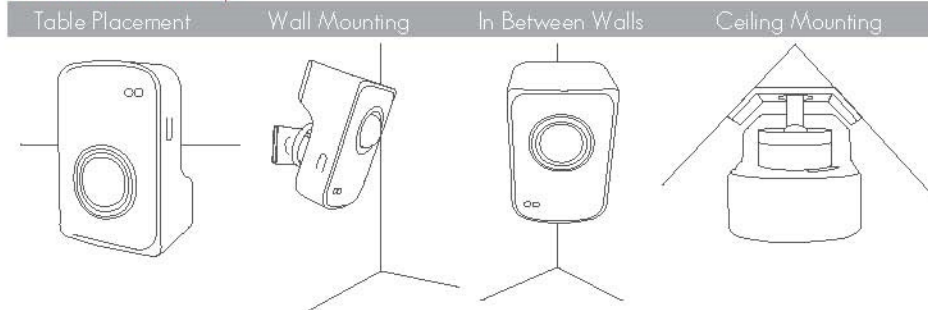

## Installation Friendly

Device box turn red when detect movement.



Tap the red box to disarm the device.

Testing : Leave the room for the sensor you are testing then wait 1 minute. Re-enter the room and the APP will receiving a notification showing "Motion Sensor is triggered."
