INTRODUCTION

SmartStick+ is a USB v2.0 full speed low power CDC-ACM compliant Z-Wave adapter in a thumb drive form factor. When plugged into computer or similar host device, it appears as a serial port so no additional drivers are required.

OPERATION

SmartStick+ is an independently controlled Z-Wave hub that requires an application from a third party to operate. The application will control such function as Inclusion, Exclusion and Replication.

Inclusion – The process of including a node into the Z-Wave network

Exclusion – The process of excluding a node from the Z-Wave network

Replication – The process of replicating network information from one controller to another

This product can be included and operated in any Z-Wave network with other Z-Wave certified devices from other manufacturers. All non-battery operated nodes within the network will act as repeaters, regardless of vendor, to increase reliability of the network.

UPGRADE ABILITY

SmartStick+ is designed to support upgrades via the USB port.

IMPORTANT !!!
