Insert SIM Card

Before connecting the MC935D to your computer for the first time, you must insert the SIM card supplied by your service provider.

Remove the cover by sliding it away from the USB connector



Insert the SIM card into Ovation MC935D. Ensure the orientation notch is positioned as shown



- Push the SIM card completely into the slot
- Replace the cover securely

Caring for Your Device

• Avoid storing your device in extreme temperatures.
