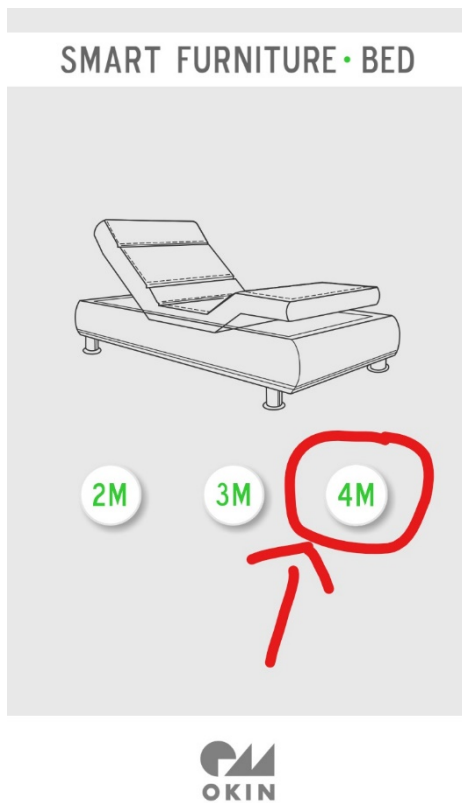
1. Open the NewOreBeding application

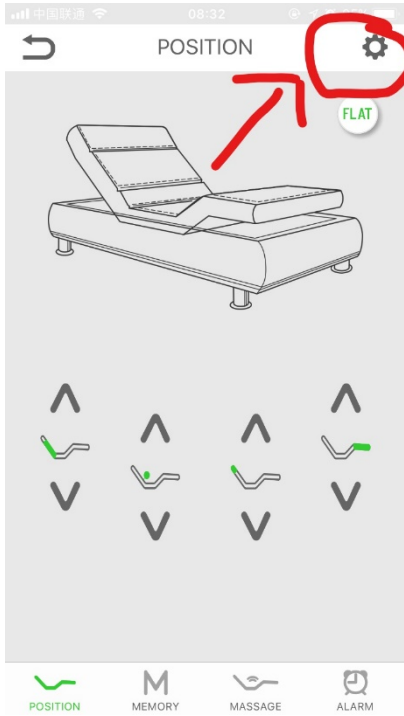

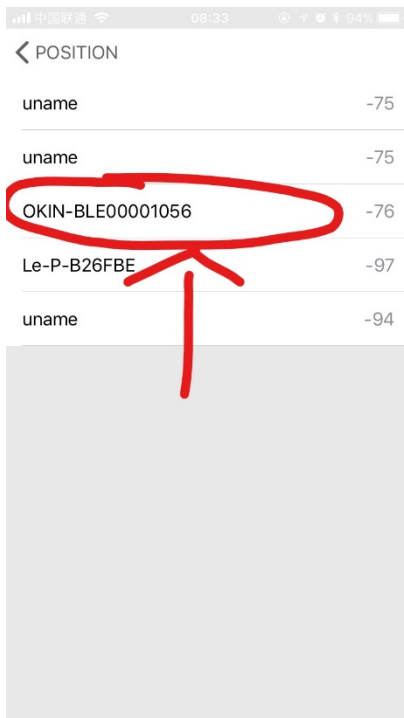
2. Select the current control box is a few motor systems
