Identify the position of the vehicle's battery (this may vary according to the type of vehicle) on which the Supereasy is to be fitted. The location of the battery is generally indicated in the user manual provided by the vehicle manufacturer. Important: should it not be possible to install the product on the battery due to insufficient space or because of high levels of vibration, select an equivalent position integral with the vehicle's chassis.

Remove the battery casing (if there is one) and thoroughly clean the surface to which the Supereasy is to be fixed using the wipe provided.

Important: do not use the wipe to clean your face and hands. The product is highly flammable and irritating for the eyes.

### PHASE 3

Remove the protective film from the adhesive under the product and fix the Supereasy to the battery, making sure it is in a horizontal position. Important: the arrow on the product must point forward, in the direction that the vehicle will be moving.

### PHASE 4

Connecting up. Connect the cable terminal with the black end to the negative pole (-) of the battery and the one with the red end to the positive pole (+) of the battery.

The nuts must only be loosened enough to allow the terminals to be fixed in place: do not remove the battery terminals. If the product LED indicator lights up, installation has been completed correctly. Important: when loosening the battery terminal nuts with the wrench, take care not to create an electric contact between the poles of the battery itself.

Shortly after the Supereasy has been connected to the vehicle's battery you will receive a text message confirming that installation has been completed. Important: if you don't receive your welcome SMS to Octo services, check if the Supereasy LED warning light is working correctly and make sure you have associated the product correctly with your service contract, as explained at the beginning of the section "Self installation".

### Maintenance mode

In the event of maintenance on the vehicle that requires removal of the battery or removal of Supereasy, to avoid registration of unnecessary data, such as indications of battery tampering or crashes caused by improper handling, the customer is asked to contact Octo so that the device can be set to maintenance mode. Once the work has been completed and the product has been properly re-connected to the vehicle's battery it will become operational again, as soon as the vehicle starts to move.

### Removal of the product

Insert a flat tool between the Supereasy and the battery to detach the adhesive. Important: never pull the product off by

To install the product again, use the double- sided adhesive provided, after cleaning the surface thoroughly with isopropyl alcohol.

WARNING: the device is protected (IP65) by accidental entry of dust, extraneous bodies and low-pressure water spurts. DO NOT install the device in vehicle's zones exposed to atmospheric agents, DO NOT expose the device to high pressure water jets (car wash, water nozzles etc.). Protect the device adequately before exposing the vehicle to high pressure water jets or in case the use of the vehicle should excelled normal conditions.
