1. Introduction:

iQ ZigBee RF Controller board is designed for Osram internal use only. 5. End Product Labeling Requirements

- The following statements shall be placed in the manual of the end product as this RF Controller board is considered extremely small (~8 x 10cm).

“This device complies with Part 15 of the FCC Rules. Operation is subject to the following two conditions: (1) this device may not cause harmful interference, and (2) this device must accept any interference received, including interference that may cause undesired operation.”

- The final end product must be labeled in a visible area with the following:

“Contains Transmitter Module FCC ID: DZO-OSREFRMG13W”

“Contains Transmitter Module IC: 23566-OSREFRMG13W”

OR

“Contains FCC ID: DZO-OSREFRMG13W”

“Contains IC: 23566-OSREFRMG13W”

OR similar wording.

6. End Product User Manual Requirements

- The user manual for the end product must include the following information in a prominent location:

“To comply with FCC and Industry Canada RF radiation exposure limits for general population/uncontrolled exposure, the antenna(s) used for this transmitter must be installed such that a minimum separation distance of 20cm is maintained between the radiator (antenna) and all persons at all times.
