This Supplementary Instructions manual points out cases where the operation of the computer will differ from that in the Operating Instructions.

### For U.S.A

Replace the "Federal Communications Commission Radio Frequency Interference Statement" ( Poperating Instructions "Read Me First") with the following.

#### Federal Communications Commission Radio Frequency Interference Statement
